Kansas had 14th Most "Distraction-affected" Crash Deaths in Nation Distracted driving crashes kill 9 people per day in America

AAA unveils new public service announcement during national distracted driving awareness month.

WICHITA, Kan. – As traffic begins to pick up across the country with increased vaccinations and decreased pandemic restrictions, AAA Kansas reminds drivers about the importance of focusing on the road ahead and not on their smartphones during National Distracted Driving Awareness month.

This year, AAA continues its distracted driving

prevention initiative titled a red light or stop sign and Analysis Reporting Sys-"Don't Drive Intoxicated. Don't Drive Intexticated." The goal of the multi-year, multi-media campaign is to remind drivers that the consequences of both alcohol-impaired driving and smartphone use behind the wheel could be the same crashes that result in deaths and injuries. According to AAA Foundation for Traffic Safety analysis of 2019 Fatality

tem (FARS) data from the National Highway Traffic Safety Administration (NHTSA), 73 people died in Kansas in 2019 as a result of "distraction-affected" vehicle crashes. Those 73 fatalities ranked Kansas 14th in the nation in distracted-driving fatalities, despite the Sunflower State having the 35th largest population.

A distraction-affected crash is any crash in which a police identified the driver as distracted at the time of the crash. Distraction can be attributed to 17 different causes as identified by the FARS database. These attributes include smartphones: general driver inattention; eating, drinking or smoking; passengers; distractions outside the vehicle; a moving object in the vehicle; or interacting with other in-vehicle technology or controls.

National Distracted Driving Statistics

NHTSA data indicated that distracted driving crashes killed 3,142 people in the United States in 2019. an average of 9 deaths per day. That number was up 10 percent from the year before (2,839 deaths in 2018). Other key findings, include:

• Of those killed in crashes reported as involving a distracted driver, more than 17%(532) were between the ages of 25-35.

• In 2019, there were 462 pedestrians, 77 cyclists, and 16 other non-occupants killed in crashes that involved a driver who was reported to be distracted.

• According to federal crash data, more than 13% of

distraction-affected crashes involved confirmed use of smartphone. This represents roughly 1.2% of all fatal crashes, which underscores that while smartphone use is most frequently blamed for driver distraction, there are many other causes of distraction-affected crashes.

Distracted driving remains a growing traffic safety problem according to the AAAFoundation for Traffic Safety's 2019 Traffic Safety Culture Index. The survey found most drivers (96%) believe typing or reading on a hand-held cellphone while driving to be very or extremely dangerous, but 39% admit to reading and 29% admit to typing on a smartphone at least once while behind the wheel within the last month.

"Hangover effect"

Even though using a hand-held device is illegal while driving and while stopped at a red light or stop sign in many states, the survey suggests some drivers do so anyway and aren't aware of the "hangover effect," which comes from interacting with technology while on the road. In a study by the AAA Foundation for Traffic Safety, researchers found drivers can experience a "hangover effect" where the mind stays distracted for up to 27 seconds after using smartphones or voice-to-text vehicle infotainment systems to send text messages, make phone calls or update social media. "Even if drivers perform

some of these tasks while parked, or stopped at a red light, once you start moving, and even after you stop using the technology, your mind is still not fully focused on the task of driving for up to 27 seconds," said Shawn Steward, Public and Government Affairs Manager for AAAKansas. "This is a dangerous situation that could lead to inattention blindness, where you're looking at the road but not seeing what's in front of you, putting other drivers, bicyclists, and pedestrians at risk."

AAA Kansas encourages all motorists to eliminate distracted driving by following these tips:

• Put it away. Place your mobile device out of sight to prevent temptation.

• Know where you're going. If using a navigation system, program the destination before driving.

• Pull over. If you must call or text while on the road, pull off the road safely and stop first.

• Ask passengers for help. If riding with someone, seek their help to navigate, make a call or send a message.

• Be a good passenger. Speak out if the driver of your vehicle is distracted.

• Don't be a distraction. Avoid calling or texting others when you know they are driving.

•Activate Do Not Disturb. Setting up this feature on iPhone or Android device will prevent calls from coming in while you're driving.

· Everyone should prevent being intexticated. Just as drivers need to pay attention, so do pedestrians and bicyclists. Never call, text or play games while walking or cycling.
