# Taxpayers may receive a refund for taxes paid on 2020 unemployment compensation

The IRS is reviewing tax returns filed before the American Rescue Plan of 2021 became law in March to determine the correct taxable amount of unemployment compensation and tax. For eligible taxpayers, this could result in a refund, a reduced balance due or no change to tax.

IRS efforts to correct unemployment compensation overpay-

ments will help most from taxable income affected taxpayers avoid filing an amended tax return. Some taxpavers will receive refunds, which will be issued periodically, and some will have the overpayment applied to taxes due or other debts. For some there will be no change.

The American Rescue Plan Act of 2021 excluded up to \$10,200 in unemployment compensation per taxpayer

paid in 2020. Taxpayers should not have been taxed on up to \$10,200 of the unemployment compensation. This is not the amount of the refund taxpayers will recieve.

Other adjustments

The agency is also making corrections for the earned income tax credit, premium tax

# Native Sons and Daughters of Greater Kansas City Announces Annual Awards

The Native Sons and Daughters of Greater Kansas City (NSDKC) is announcing its annual awards to individuals who have contributed significantly to the promotion and or preservation of a recognized historical site and/or location within the 10 counties where the majority of the organization's members reside. NSDKC was founded in 1932.

The James Anderson Historic Preservation Award is being presented to Mr. Chester C. Owens, Jr. Mr. Owens has a long record of civic involvement in Kansas City, Kansas and the region that spans six decades. Owens' career was in insurance. He was elected county wide to serve on the Unified Government Board of Commissioners of Wyandotte County/Kansas City, Kansas and served on the board of directors of the former Douglass State Bank, one of only two African-American-owned banks that ever existed in Greater Kansas City.

Mr. Owens has an extensive record of involvement with the NAACP and has been recognized many times for his leadership efforts. He is a driving force behind the preservation of the history of Sumner High School. Sumner was Kansas' only all-black high school throughout its storied existence between 1905 and 1977, when a federal designation order forced its closure. Many of its graduates went on to have professional careers in law, medicine, sports and business. The school reopened as the Sumner Academy Arts and Sciences. The Chester C. Owens Sumner Alumni Room was established to preserve the original





school's history. He is a graduate of Pittsburg State University.

In recent years. Mr. Owens has been heavily involved in the development of the Old Quindaro Museum adjacent to 1-635 and Leavenworth Road in Kansas City, Kansas. The Quindaro Ruins Overlook provides a dramatic view of the Missouri River looking toward Paxkville, Missouri where many slaves are believed to have escaped to freedom between 1859 and 1862. The ruins of Western University and a statue of abolitionist John Brown are near the Overlook. The NSDKC 's Special Recognition Award was presented to Anna Marie Tutera of Kansas City, Missouri. Tutera is executive director of the newly restored and renovated Kansas City Museum, located at 3218 Gladstone Boulevard. The Museum is owned and operated by the City of Kansas City, Missouri.

Tutera plans to restore the facility's tradition of varied program offerings for visitors. At the peak of its prominence from the 1940s through the 1970s, generations of school children from across the metropolitan area were bused in field trips to view its vast collections of regional artifacts on display. Ms. Tutera received her BS degree from Northwestern University in Evanston, IL, and then earn an MS in Museum Studies at John F. Kennedy University. Previously, she was executive director of the John Wornall/ Majors House Museums in Kansas City,. Missouri.



credit and recovery rebate credit affected by the exclusion.

The IRS can adjust tax returns for those who are single with no children and who become eligible for EITC. The IRS also can adjust tax returns where EITC was claimed and qualifying children identified.

Taxpavers who have qualifying children and become newly eligible for EITC after the exclusion is calculated may have to file an amended return to claim any new benefits.

If the IRS adjusts someone's tax return,

the taxpayer will receive a letter within about 30 days, explaining what kind of adjustment was made and the amount of the adjustment. Types of adjustments include a refund, payment of IRS debt or payment offset for other authorized debts. Offsets include past-due federal tax, state income tax. state unemployment compensation debts, child support, spousal support or certain federal nontax debts, such as student loans.

Taxpayers should keep any IRS notices for their records and review their tax return after receiving any IRS notices.
