### Governor Kelly Announces More Than \$2 Million in Federal Grant Funding to Reduce Crime, Improve Public Safety

TOPEKA – Governor Laura Kelly, on behalf of the Kansas Criminal Justice Coordinating Council (KCJCC), today announced that more than \$2 million will be awarded to Kansas criminal justice organizations as part of the 2022 grant awards for the Federal Edward Byrne Memorial Justice Assistance Grant (JAG) Program.

"These grant funds will provide our law enforcement and criminal justice agencies with the resources they need to keep Kansans safe," Governor Kelly said. "I appreciate our partners at the U.S. Department of Justice for their support. My administration will continue leveraging every resource and seeking opportunities to make needed reforms in our criminal justice system and improve public safety for every person in our state."

The KCJCC oversees the criminal justice federal funding made available to Kansas through the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance. The KCJCC membership is representative of the Governor, Chief Justice of the Supreme Court, the Attorney General, the Secretary of Corrections, the Superintendent of the Kansas Highway Patrol, and the Director of the Kansas Bureau of Investigation.

The U.S. Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community. A total of \$2,396,959 was awarded to 25 agencies.

### New Wyco Connect Program Links People Living in Wyandotte County to Important COVID-19 Community Resources

With vaccine rates lagging and the COVID-19 virus still haunting our community, the Unified Government of Wyandotte County/Kansas City, Kansas's Public Health Department (UGPHD) and the Community Health Council of Wyandotte County (CHC) have combined their forces and missions to help slow the spread of the virus in our community. Through collaboration and care, they created the WyCo Connect initiative to address the critical issues of the community.

This initiative brought on and trained 17 new Community Health Workers (CHWs) directly from historically marginalized communities in Kansas City, Kansas and Wyandotte County. The initiative supports racial and ethnic groups impacted by COVID and various health inequities such as African American, Latinx and Hispanic, refugee, and immigrant communities as well as people living in 66101, 66102, 66104, and 66105 zip codes. WyCo Connect will have these CHWs helping in the community until the end of 2022, allowing time for people to receive COVID-related assistance as well as access to the vaccine and the available resources.

WyCo Connect Community Resources

These CHWs are designated to a variety of tasks in an effort to reduce the burden of the virus on Wyandotte County, especially on people from historically oppressed communities. They walk alongside those in the community to assess their needs as well as their access to COVID-19 specific healthcare and resources. CHW tasks include, but are not limited to:

• Educating and connecting individuals from targeted communities on several COVID-19 issues like the vaccine, testing and address personal and communal hesitancies about vaccine and its benefits

- Connecting individuals to free COVID-19 related resources, such as:
- COVID-19 testing and vaccines at community locations or delivered to people's homes

• Quarantine housing for people who have been exposed to COVID-19 or who have tested positive. This resource includes meals and cleaning services.

• Food assistance for people who are in quarantine or who have reduced food access due to COVID-19.

• Transportation to access COVID-19 vaccines and testing for anyone who lives in Wyandotte County. Free rides to other social services are available to zip codes 66101, 66102,

66104 and 66105. Funding for this resource is provided by Health

Forward Foundation. Assisting with health navigation like finding a primary doctor or safety-net clinic.

• Receive, interpret, and utilize feedback to address ways the UGPHD and WyCo Connect can increase equity in vaccine campaigns and dismantle barriers people may face accessing the vaccine, testing and other COVID related programs and services

• Most importantly, walk alongside those in the community to address their physical, mental, social, and economic needs and access to COVID-19 specific healthcare opportunities and resources

Impact of COVID-19 on the community

Throughout the pandemic, COVID-19 rate of positivity and death totals have substantially been higher in Wyandotte County as compared to other local jurisdictions. Wyandotte County has experienced inequalities which have impacted the vaccination rates among communities of color and target populations. The county's vaccination rate has improved significantly through the course of 2021, but at just over 50%, still lags behind the vaccination rate for the U.S. and is not at a level of herd immunity. Lower vaccination rates can be attributed to countless barriers and accessibilities impacting target populations, such as healthcare, language, transportation, income constraints, housing instability, and an overall mistrust of medical and governmental institutions. This is why WyCo Connect is focused more heavily on specific communities and zip codes that have faced more of these barriers and health inequities, both during and long before the pandemic.

## Medicare Open Enrollment Is Underway: Free Counseling Available

TOPEKA – More than 553,000 Kansas residents receive health coverage through Medicare, and the time to review their benefits is here. The open enrollment period for Medicare coverage in 2022 began October 15, 2021 and runs through December 7, 2021.

"Older adults can use this 7-week period to sign up for Medicare for the first time. and current Medicare beneficiaries can make changes to several aspects of their coverage as well," said Kansas Department for Aging and Disability Services (KDADS) Secretary Laura Howard. "If you're already enrolled, this is an opportunity to review your options for coverage and make adjustments if necessary, so it better meets your needs.'

By shopping available plans and comparing costs, beneficiaries may be able to find a Medicare health or drug plan with better coverage or a lower premium in 2022. The Medicare Plan Finder allows users to compare pricing between Original Medicare, Medicare prescription drug plans, Medicare Advantage plans, and Medicare Supplement Insurance (Medigap) policies. During open enrollment, those currently

enrolled may: \* Switch from original Medicare to Medicare Advantage, or vice versa

\* Switch from one Medicare Advantage plan to another or from one Medicare Part D prescription drug plan to another

\* If you didn't enroll in a Medicare Part D plan when you were first eligible, you can do so during open enrollment, although a late enrollment penalty may apply

If you want to enroll in a Medicare Advantage plan, you must meet some basic criteria:

\* You must be enrolled in Medicare Part A and B

\* You must live in the plan's service area

If you're already enrolled in a Medicare Part D prescription plan or a Medicare Advantage Plan and you don't want to make changes to your coverage for 2022, you don't need to do anything during open enrollment, assuming your current plan will still be available in 2022. If your plan is being discontinued and isn't eligible for renewal, you will receive a non-renewal notice from your carrier prior to open enrollment. If you don't, it means you can keep your plan without doing anything during open enrollment.

Be aware that benefits and premiums could be changing for 2022. So even if you're confident you want to keep your current coverage for the coming year, it's important to understand any changes that may apply and check to make sure your current plan is still the best available option. The available plans and what they cover change from one year to the next, so even if the plan you have now was the best option when you shopped last year, it's important to verify that again before you lock yourself in for another year.

Each year, there's a Medicare Advantage Open Enrollment Period from January 1 – March 31. During this time, if you're in a Medicare Advantage Plan and want to change your health plan, you can switch to a different Medicare Advantage Plan with or without drug coverage or go back to Original Medicare and, if needed, also join a Medicare Prescription Drug Plan. Changes to be aware of for 2022 include:

\*Medicare Advantage plans are available in 2022: 88 compared to 79 plans in 2021.

\* 100 percent of people with Medicare have access to a Medicare Advantage plan.

\*The average monthly Medicare Advantage premium changed from \$9.53 in 2021 to \$7.79 in 2022. This represents a -18.19 percent change in average premium.

\* 29 Medicare prescription drug plans are available with premiums varying from \$6.60 to \$101.40.

\* 100 percent of people with a stand-alone Medicare prescription drug plan have access to a plan with a lower premium than what they paid in 2021.

\* Eight stand-alone Medicare prescription drug plans and 29 Medicare Advantage plans with prescription drug coverage will offer lower out-of-pocket insulin costs through the Part D Senior Savings Model.

\* Through the CMS Innovation Center's Value-Based Insurance Design (VBID) Model, 16 plans will offer Medicare Advantage enrollees eliminated Part D cost-sharing; rewards and incentives programs related to healthy behaviors; and customized, innovative benefits that address social determinants of health, such as food insecurity and social isolation, for certain underserved and/or
