# AG Schmidt urges better disclosure, clarity from GoFundMe

TOPEKA - Kansas Attorney General Derek Schmidt is urging the owners of the Go-FundMe payment platform to make meaningful changes in their disclosure policies to give Kansas consumers greater clarity on where their donations are going.

Schmidt was part of a bipartisan coalition of 28 state and territory attorneys general that sent a letter yesterday to GoFundMe outlining specific steps that they would like to see implemented to the crowdfunding platform. Users of the site pay a fee of 2.2-2.9%, plus 30 cents per transaction. But information on the terms of service and policies, particularly related to blocking, freezing, refunding, and re-directing donations, is hard to find and unclear

"Platforms like GoFund-Me are not and should not be empowered to unilaterally make decisions regarding where donated funds will go or why," the attorneys general wrote. "If GoFundMe is making opaque and unilateral decisions about which fundraisers are legitimate and which fundraisers to re-route donations to irrespective of initial donor choice, GoFund-Me has likely crossed the line from fundraising platform to fundraiser itself. Such a role implicates significantly different regulatory schemes

directed at ensuring transparency in charitable giving."

The attorneys general ask GoFundMe to take the following steps:

- \* Explain in detail how GoFundMe investigates or analyzes fundraisers on its platform, and what criteria GoFundMe uses to determine whether those fundraisers are fundraising for acceptable purposes;
- \* Explain in detail how Go-FundMe determines whether to block, freeze, re-direct, or refund donations, and what criteria GoFundMe uses to decide which avenue to take;
- \* Explain in detail how Go-FundMe handles donations when GoFundMe decides

freeze donations or and/or (iii) re-direct donations;

\* Review its policies and terms of service to ensure that donors are adequately and conspicuously informed at the time of their donation of the circumstances under

to (i) block donations, (ii) which their donation may be blocked, frozen, re-directed or refunded without their authorization by conspicuously disclosing those circumstances through the user interface;

\* Explain in detail the meaning of the term "unacceptable" in the context of its terms of service and describe whether there are additional internal policies defining it; and

\* Articulate any steps being taken to address these issues in the form of a responsive letter or a meeting with the attorneys general.

# **Don't Let Severe Weather Uproot** Your Financial Well-Being

Topeka, Kan. - Severe weather season has begun; a time when we see more tornadoes tossing, hailstorms denting, and rainwater flooding. As Kansas enters severe weather season, the Kansas Insurance Department encourages Kansans to evaluate their property insurance needs by reviewing any changes in their life over the past year and looking for potential insurance gaps. The following are some of the costliest insurance gaps Kansans can face:

- 1. Flood Most homeowners believe their standard homeowner policy covers flooding if they are not in a flood plain, but that assumption is incorrect. Consider your own risk tolerance and a property's proximity to flooding areas. There is a 30-day waiting period for your flood coverage to be effective from the date of purchase, so do not wait until the storm. Visit floodsmart.gov to learn more about flood zones and how to purchase flood insurance.
- 2. Roof A policy that covers a damaged roof with "actual cash value (ACV)" will only pay for the amount it would take to repair or replace damage to your roof after accounting for depreciation. A policy that covers a damaged roof with "replacement cost" will reimburse the full amount, less the policy deductible, to repair or replace a damaged roof with materials of similar kind and quality at today's price. There is a cost difference for both the premium and the damage repair between ACV and replacement cost. Make sure you understand what you have and the pros and cons of that coverage.
- 3. Sump pump failure Standard homeowners' insurance does not cover damage caused by a sump pump not working properly. Homeowners need to select an endorsement/rider that covers sewer backup and mechanical failure of a sump pump to help cover the costs

As Spring storms roll in, the Department would like to remind Kansans with insurance questions to visit insurance.kansas.gov for helpful shopper guides. Be sure to contact your agent to conduct a review of your current policy and ensure you do not have coverage gaps based on your needs.

## **Governor Kelly Signs Bill Increasing Penalties for** Child Abuse Offenders

## House Bill 2508 Clarifies Definition of Child Abuse and Provides More Severe Sentencing of Offenders

TOPEKA - Governor Laura Kelly announced she signed House Bill 2508, a bipartisan bill that further defines child abuse expands allowable charges prosecutors can file for the crime. In addition, HB 2508 allows for more specific sentencing based on the severity of abuse, putting the crime of child abuse in line with other severe crimes

'We owe it to our children to hold abusers accountable and any crime against our most vulnerable should be met with adequate punishment," Governor Laura Kelly said. "This bill provides the needed updates for prosecutors to ensure victims of child abuse are granted the same justice as victims of other serious crimes.'

'House Bill 2508 includes a number of provisions that were brought to the House Judiciary Committee by law enforcement, prosecutors, and other stakeholders who are working to improve our criminal justice system," Representative Fred Patton said. "The bill makes several key improvements to our justice system, including increasing penalties for those who cause harm to our most vulnerable Kansans, our children. I am pleased that the Senate agreed with these changes and that the Governor is signing the bill so the provisions can become law."
