Unmasking Domestic Violence

The WyCo Sisterhood Foundation is holding its first annual fundraiser, a Masquerade Ball, on Saturday, October 29th, on the grounds of the Kansas City Renaissance Festival. The event will feature music and other live entertainment, a costume contest, and a raffle and silent auction. Proceeds will assist Friends of Yates in “unmasking domestic violence and creating safer homes.”

The WyCo Sisterhood Foundation (wycosf.org) was founded in 2019 by volunteers who worked at the Kansas City Renaissance Festival to raise money for local charities. By starting their own foundation, they have been better able to address the needs of the community directly.

Friends of Yates (friendsofyates.org) opened Wyandotte County's first emergency domestic violence shelter in 1980, and continues to offer assistance, education, prevention services and resources to those affected by this crisis. Friends of Yates is part of the Metropolitan Family Violence Coalition, a collaborative effort committed to providing services for domestic violence victims throughout the Kansas City area.

VIP admission for the Masquerade Ball is \$60 and includes dinner and a happy hour beginning at 5:30 pm. General admission begins at 8:30 pm; tickets are \$25 online and \$30 at the door. Anyone who brings a new or gently-used coat to donate to students in the Bonner Springs School District will receive a free raffle ticket.

TAKE NOTICE that the property described herein has been seized for forfeiture, and it or substitute assets are pending forfeiture to the Edwardsville, Kansas Police Department ("EPD") pursuant to the Kansas Standard Asset Seizure and Forfeiture Act ("the Act"), K.S.A. 60-4101 et seq. Governor Announces \$17 Million Coming to Kansas to Address the Opioid Crisis

TOPEKA – Governor Laura Kelly announced that the State of Kansas and the Kickapoo Tribe in Kansas (KTIK) have together received \$17.2 million in federal grant funding to address the opioid crisis. The funding will be used to increase access to treatment for substance use disorders, remove barriers to public health interventions like naloxone, and expand access to recovery support services.

“The opioid crisis impacts families across Kansas, which is why it’s critical that we make opioid treatment and prevention resources available in every community,” Governor Laura Kelly said. “This funding will help make that possible, and in doing so save lives and bring relief to struggling Kansans.”

The Kansas Department for Aging and Disability Services (KDADS) has received more than \$16.7 million, and the KTIK has received \$500,000 in federal grant funding to address

the opioid crisis and support individuals in recovery.

The funding, provided through the Substance Abuse and Mental Health Services Administration (SAMHSA), will support states, tribal lands, and territories’ opioid response efforts. The grants are part of National Recovery Month and SAMHSA’s State Opioid Response (SOR) and Tribal Opioid Response (TOR) grant programs.

For KDADS, this grant will provide access to medication-assisted treatment to reduce overdose deaths for Kansans with opioid use disorder or stimulant use disorder. Strategies and interventions will focus on evidence-based prevention, treatment, and recovery support services for the illicit use of prescription opioids, heroin, fentanyl, fentanyl analogs, and psychostimulants.

The funding will also allow Kansas to increase investments in overdose education, peer support

specialists in emergency departments, and allow states to invest in other strategies that will help save lives in hard-hit communities.

“Our prevention and addiction teams recognize the dangers of opioids in our cities and rural areas and the damaging impact they have on so many lives,” said KDADS Secretary Laura Howard. “I’m glad to support Governor Kelly and her administration’s effort to ensure this crisis is addressed across the state and in every community.”

KTIK will develop a holistic TOR program, KTIK Return to Community (R2C), that includes prevention; screening; treatment; and peer-led recovery for opioid, stimulant, and other substance use.

“The opioid crisis has had a devastating effect on tribal nations throughout the U.S.,” Lester Randall, Kickapoo Tribal Chairman, said. “It’s a relief to see addiction and opioid

crisis funding coming in to underserved communities to assist our efforts in increasing access to treatment and supporting individuals

in recovery. The funds coming into the Kickapoo Tribe from opioid grants and settlements are going to result in lives saved and

a preventative trajectory for our people.”

The state and tribal grants run until September 29, 2024.

Fire Prevention: Kiddo Edition

From toddlers taking their first steps to excited grandchildren waiting to lick leftover cake batter, the adventurous and playful nature of children that surround us often requires conforming in ways that protect the young and innocent. As a participant in National Fire Prevention Week, Kansas Insurance Commissioner Vicki Schmidt would like to highlight several kid-friendly fire prevention efforts Kansans should consider in their efforts to keep their family and property safe.

1. Out of sight, out of mind – Keep lighters, matches and other flammable substances in a safe location out of reach from children. Household lighters should include child-proof features.
2. Go flameless – Light bulb-illuminated candles are a safe option to consider around kids.
3. Turn the handles away – When cooking around children (and pets), never have pot handles hanging near or over the edge of a stove. Keep all handles facing towards the back of the stove.
4. Enforce the three-foot rule – Teach children to stay three feet back from things that get hot. Space heaters, active fireplaces, and stoves should be no-go zones for children.
5. Keep the yard clean – Keeping your yard clean of dry leaves and pine needles is an important step in building an ember-resistant zone around your property.

“Fireproofing your home and purchasing homeowners or renters insurance are critical steps you can take to protect your family and personal property,” said Kansas Insurance Commissioner Vicki Schmidt.


