## Riobé Named Vice President for Educational Innovation and Global Programs at KCKCC

Kansas City Kansas Community College is pleased to welcome Dr. Fabiola Riobé who will be the college's first vice president for Educational Innovation and Global Programs.

"KCKCC is excited to welcome Dr. Riobé to the Blue Devil family," said KCKCC President Dr. Greg Mosier. "She brings a wealth of experience and a unique insight in developing innovative educational offerings, workforce solutions and international partnerships."

Riobé comes to KCKCC from SUNY Rockland Com-

munity College in Suffern, N.Y., where she served as the associate provost for Academic Innovation, On-line Education and Global Opportunities. In this role, she led career and professional development, academic technology and instructional design as well as E-Learning, global engagement, academic and career strategies and strategic initiatives. During the COVID-19 pandemic, she guided the college through the transition to on-line and technology-assisted instruction. She also facilitated the process to create a new

strategic plan, co-designed a program for New Accepted Student Day and designed a user interface to create training recommendations and faculty assignments.

"I am excited to join the KCKCC family as the inaugural vice president for Educational Innovation and Global Programs. As we embark on this journey together, remember that our work is not confined to the limitations of our job titles," she said. "I look forward to collaborating with others to achieve the president's vision to foster an atmosphere where

innovation thrives, diverse voices are amplified, and every member feels valued, respected and supported. Our commitment to service extends beyond our college walls, reaching into the wider world to address pressing challenges, shape a brighter future and create a legacy that will resonate for years."

Prior to Rockland, Riobé was the president and executive director of Community Colleges for International Development in Houston; the founding director and master teacher for the American Cultural Association, American Language Center in Morocco; director and professional work fellow for ETS in Princeton, N.J. and a Wall Street Market Research, International Consultant for MENA, West Africa Region in London.

Among her key career accomplishments has been writing curriculum for sum-

mer arts and language camps that received \$500,000 in funding to support rural and low-income children in Morocco across 12 cities. Riobé increased revenue and saved 25 percent in expenses by developing an information technology roadmap that eliminated the use of paper score reports in China.

Riobé received a bachelor of arts in social science from the State University of New York and both a master of business administration and master of arts in international relations from Schiller International University in France. She then received a doctor of education, leadership from Ferris State University in Big Rapids, Mich. as well



as several additional certificates. She is a member of Phi Delta Kappa and Alpha Kappa Alpha Sorority, Inc., a mentor for the African Women Economic Consortium and has been on the board of directors for the YMCA in Rockland, N.Y.
