Kansas City, Kansas Public Library opens Imprinting the West: Manifest Destiny, Real And Imagined on September 1

Throughout the nineteenth century as Americans pushed west toward the Pacific, they were fascinated by westward expansion in North America. Printed imagery—lithographs and engravings—played an important role in the dissemination of knowledge and

understanding about the West and its inhabitants. Now visitors to Kansas City, Kansas Public Library's new exhibition, Imprinting the West: Manifest Destiny, Real and Imagined, opening September 1, will see 48 lithographs that explore these depictions and the influence the artists had on the perception of the wild west. In 1803, President Thomas Jefferson purchased the expansive territory, known as Louisiana from Napoleon, King of France. This transaction extended the young country's boundaries by 828,000 square miles, including all of present-day Arkansas, Iowa, Kansas,

hand-colored engravings and Missouri, Oklahoma, and parts of Colorado, Louisiana, Minnesota, Montana, New Mexico, North Dakota, South Dakota, Texas, and Wyoming. The Louisiana Purchase set the stage for exploration, migration and settlement, in addition to struggle and conflict. Convinced that God wanted the country to extend to the Pacific Coast—the idea called "Manifest Destiny"scores of Americans, including painters and printmakers, moved west.

The westward expansion

in the nineteenth century was closely intertwined with the experiences of the native peoples. The exhibition's artists, including George Catlin and Frederic Remington, sought to document the indigenous people of the west along with migration to the west. Artists often accompanied governmental geographical surveys and created images to illustrate official publications. Others sold engravings to popular periodicals, such as Harper's Weekly, or to the mass market. Whether real or imagined, these lithographs and engravings informed the rest of America and the world about Native Americans and America's western landscapes and its natural

tember 7 featuring Dr. Eric Anderson, Ph.D., Professor of History at Haskell University, who will speak about the exhibit and this time in history. Other programs include a presentation by Chief Judith Manthe on September 14 about growing up Wyandot in Kansas, and a book club series focuses on Native American identity and experience. Guidance to Consumers on Insurance **Company Liquidation**

Topeka, Kan. - Kansas Insurance Commissioner Vicki Schmidt released a new FAQ document for consumers and agents impacted by the recent liquidation of MutualAid eXchange (MAX), a Kansas domestic insurance company, following the order of liquidation from the Shawnee County District Court.

"If you are a Kansan with a MAX policy, I encourage you to visit the Liquidation FAQ's found on the Department's website to learn more about what this means for you and how to file a proof of claim," said Commissioner Schmidt. "The Department will be working closely with the deputy liquidator and the guaranty associations in the states MAX did business to pay claims and process unearned premium refunds."

The Kansas Insurance Guaranty Association was created in statute to protect the public in the event of a failure of a property and/or casualty insurance company.

With the consent of the MAX Board of Directors, Commissioner Schmidt petitioned and received the Order of Rehabilitation on August 8. After further evaluation of the company's solvency, it was determined that liquidation is necessary to pay outstanding liabilities. The petition for liquidation was granted August 22 by Shawnee County District Court.

"Kansas maintains a robust property and casualty market with options for consumers," said Commissioner Schmidt. "Unfortunately, this company fell victim to a very tough reinsurance market and catastrophic storms throughout the nation. Impacted policyholders should work with their agent as soon as possible to obtain replacement coverage."

MAX is a domestic reciprocal or inter-insurance exchange company licensed in 28 states. They organized under the laws of the state of Kansas on January 1, 2001. They recently had approximately 30,000 policies in force nationwide, with 1,390 of those in Kansas.

A RESOLUTION CALLING AND PROVIDING FOR THE GIVING OF NOTICE OF A PUBLIC HEARING ON THE ADVISABILITY OF CREATING A COMMUNITY IMPROVEMENT DISTRICT IN THE UNIFIED GOVERNMENT OF WYANDOTTE COUNTY/ KANSAS CITY, KANSAS TO BE KNOWN AS THE HOMEFIELD COMMUNITY IMPROVEMENT DISTRICT AND REGARDING THE UNIFIED GOVERNMENT'S INTENT TO LEVY COMMUNITY IMPROVEMENT DISTRICT SPECIAL ASSESSMENTS AND SALES TAX WITHIN SUCH DISTRICT AND ISSUE SPECIAL OBLIGATION BONDS.

WHEREAS, K.S.A. 12-6a26 et. seq. (the "Act") authorizes the governing body of any city or county to create community improvement districts to finance projects within such defined area of the city or county and to levy community improvement district special assessments and a sales tax upon property within the district and issue special obligation bonds to finance

projects; and WHEREAS, a petition dated August 7, 2023 (the "Petition") was filed with the Unified Government Clerk proposing the creation of the Homefield Community Improvement District (the "CID") under the Act, the imposition of a 2.0% sales tax (as described herein, the "CID Sales Tax") and certain special assessments (as described herein, the "CID Special Assessments"), and the issuance of special obligation bonds (the "CID Bonds") in order to pay the costs of projects as described herein and in the Petition (collectively, the "Projects"); and

WHEREAS, the Petition was signed by the required number of owners of record, whether resident or not, as required by the Act; and

WHEREAS, the Unified Government of Wyandotte County/ Kansas City, Kansas (the "Unified Government") intends to consider creation of the CID, levying the CID Sales Tax, imposing the CID Special Assessments, and issuing the CID Bonds as requested in the Petition; and

WHEREAS, the Unified Government Board of Commissioners hereby finds and determines it to be necessary to direct and order a public hearing on the advisability of creating the CID, approving the Projects, levying the CID Sales Tax, imposing the CID Special Assessments, and issuing the CID Bonds pursuant to the authority of the Act and further to provide for the giving

of notice of said hearing in the manner required by the Act.

NOW, THEREFORE, BE IT RESOLVED BY THE UNIFIED

GOVERNMENT BOARD OF COMMISSIONERS, AS FOLLOWS:

SECTION 1. Petition. The Board of Commissioners of the

Unified Government (the "Governing Body") hereby finds and determines that the Petition meets the requirements of the Act.

SECTION 2. Public Hearing. It is hereby authorized, ordered, and directed that the Governing Body shall hold a public hearing, in accordance with the provisions of the Act, on the advisability of creating the CID, approving the Projects set forth in Petition, and whether to levy the CID Sales Tax, impose the CID Special Assessments, and issue the CID Bonds, such public hearing to be held on September 14, 2023, at 7:00 p.m., or as soon therafter as the matter can be heard, in the Commission Chambers, at the lobby level of the Municipal Office Building, 701 North 7th Street, Kansas City, Kansas, under the authority of the Act.

SECTION 3. Proposed Projects. The general nature of the Projects is as follows:

The development of a mixed-use commercial development located generally within the areas lying north of State Avenue, south of Parallel Parkway, west of N 86th Street, and east of Interstate 435 in Kansas City, Wyandotte County, Kansas. The Projects may be more particularly described as the construction, maintenance, and procurement of certain improvements, costs, and services within the District, including, but not limited to: infrastructure related items, sidewalks, parking lots, drainage improvements, buildings, tenant improvements, utilities, landscaping, lighting, signage, marketing and advertisement, cleaning and maintenance, security, soft costs of the Projects, and the Unified Government's and the petitioner's administrative costs in establishing and maintaining the District, and any other items permitted to be financed within the District under the Act.
