## Kansas to Receive More than \$5.4M to Improve 9-8-8 Capacity

TOPEKA–Governor Laura Kelly announced that the Kansas Department for Aging and Disability Services (KDADS) is receiving more than \$5.4 million from the U.S. Department of Health and Human Services (HHS), Substance Abuse and Mental Health Services Administration (SAMHSA). Over three years, this funding will build local capacity for the 9-8-8 Suicide & Crisis Lifeline and related crisis services.

"These funds are critical to ensure we have the staff and resources to address the mental health crisis in Kansas," Governor Laura Kelly said. "Another funding avenue would be expanding Medicaid, which is already the primary payer of behavioral health services in the United States. By expanding Medicaid, we could leverage that tool to support mental health care services further." The States and Territories

to Improve Local 9-8-8 Capacity program will provide nearly \$1.9 million in the first year and nearly \$1.8 million in the following two years to improve response to 9-8-8 contacts — calls, chats, and texts — originating in Kansas. This funding will support the program's goals of increasing workforce support for the growing 9-8-8 demand through hiring, recruiting, and training; improving the public communication of 9-8-8 services, including those for high-risk populations; and continuing to expand post-contact support connections with services such as mobile crisis outreach and crisis stabilization services to ensure adults and youth experiencing mental health crisis receive faster access to trained mental health professionals.

"Crisis support and access to mental health care and ensuring more people in crisis get the help and support they need is increasingly critical for Kansans," KDADS Secretary Laura Howard said. "Applying for and being selected to receive this new additional 9-8-8 funding reflects our state's commitment to build on the crisis care framework we have been and continue to develop and strengthen it to provide increased access across our communities."

Among other benefits, funding provided through this program will afford Kansas the ability to recruit, hire, and train additional staff to ensure state contact centers can collect and report monthly data on contacts that result in emergency rescue, suicide attempts in progress, and mobile crisis outreach referrals.

KDADS currently partners with three National Suicide Prevention Lifeline (NSPL) contact centers for 24/7 coverage of 9-8-8 calls, chats, and texts. The NSPL contact centers are Johnson County Community Mental Health (JCCMH), Sedgwick County (Comcare responds to NSPL calls), and Kansas Suicide Prevention HQ (KSPHQ). Additionally, Wyandot Behavioral Health Network Inc. is in the process of gaining certification as a contact center, and HealthSource Integrated Services (HIS) serves as a statewide backup contact center.

KDADS will partner with Comcare, JCCMHC, KSPHQ, Wyandot Behavioral Health Network, and HealthSource for this program.

In July 2022, 9-8-8 became the national three-digit dialing code for the National Suicide Prevention Lifeline, replacing the current phone number of 1-800-273-TALK (8255).

## IRS announces 2024 Tax Counseling for the Elderly and Volunteer Income Tax Assistance Program Grants

WASHINGTON-The Internal Revenue Service recently awarded \$51 million in Tax Counseling for the Elderly (TCE) and Volunteer Income Tax Assistance (VITA) grants to organizations that provide free federal tax return preparation.

This year, the IRS awarded grants to 45 TCE and 300 VITA applicants. The IRS received 429 applications requesting over \$170 million in funding.

"As a part of the transformation of IRS, connecting with communities and providing resources



through partnerships is part of our effort to ensure fair and equitable administration of taxes and provide valuable credits to those in need," said Ken Corbin, the IRS Wage and Investment commissioner. "Grants ensure that these partners have access and are available."

The TCE program, established in 1978, provides free tax counseling and federal return preparation to individuals who are age 60 or older. Volunteers receive training and technical assistance to provide assistance at community locations across the nation.

The VITA program, created in 1969, assists underserved communities, such as low- and moderate-income individuals and limited English proficient taxpayers. VITA grant recipients provide free federal tax return preparation and electronic filing. The grant program helps to expand VITA services to underserved populations.

The IRS forms partnerships with a wide variety of organizations across the country to develop VITA and TCE programs. Community partners include non-profit agencies, faithbased organizations, community centers and large employers. The IRS provides tax law training, certification and oversight to these organizations assisting their efforts to prepare accurate returns.

"VITA and TCE grant recipients work hard to improve the taxpayer experience in their own backyards," said Maryann Enciso, acting national director for Stakeholder Partnerships, Education and Communication. "We are pleased to award these grants to our dedicated partners who provide quality tax preparation and financial education and asset building in their local communities. VITA/TCE is a 'cause not a program' to help American taxpayers."

### LEGAL NOTICE **CHARTER ORDINANCE**

NO. CO-01-23 A Charter Ordinance relating

to the board of public utilities, creating a new residential class option for purposes of transferring percentages or portions of gross operating revenue, lowering the percentage cap, and reducing the amount attributable to residential accounts transferred to the unified government in each of the next six years; amending section 18 of Charter Ordinance No. CO-3-02 of the Unified Government of Wyandotte County/Kansas City, Kansas.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE UNIFIED GOVERN-MENT OF WYANDOTTE COUN-TY/KANSAS CITY, KANSAS:

Section 1. That section 18 of Charter Ordinance No. CO-3-02 of the Unified Government of Wyandotte County/Kansas City, Kansas be and the same hereby is amended to read as follows: Section 18

As hereinafter direct-(a) ed, the board is hereby empowered to transfer to the unified government: (i) a percentage or other portion of the gross oper-ating revenue of each utility; or (ii) a percentage or other portion of the gross operating revenue of each utility attributable solely to its residential accounts, and a different percentage or other portion of all other gross operating revenue of each utility attributable to all other accounts.

The amount to be (b)transferred to the unified gov-ernment under this section shall be determined by resolution by the unified government in an amount not less than five percent nor more than 15 12 percent of its gross revenues, whether combined or separated by accounts as set forth in Section 18(a)(ii), for such fiscal year. The determination of the percentage of gross operating revenues to be paid for a fiscal year shall be made by the unified government, with written notice to the board on or before September 1 the first day of October preceding the date of implementation. The governing body of the unified government and the board shall, prior to any determination increasing the payment in lieu of taxes hereunder, meet and confer to discuss any proposed increase If the unified government fails to so determine or fails to so notify the board of its determination on or before the first day of September October of any year, the board shall set over a percentage of gross operating revenues, whether combined or separated by accounts as set forth in Section 18(a)(ii), which shall be no less than that set over the preceding year.

(c) From and after the effective date of this ordinance, the set over of revenues to the unified government shall be made monthly by no later than the tenth day of the second month following each month in which the gross operating revenues are collected. For each fiscal year, following the receipt of the year's audit by the board, a determination of the total amount of revenues which should have been set over based on total gross operating revenues shall be made, and any reconciliation and adjustment between that amount and the amount which had been previously set over for the fiscal year shall be determined and such reconciliation and adjustment shall be made by adjusting the payment made in the month following receipt of the audit, upward or downward

as necessary, except that this reconciliation shall be done no later than the month of June.

On and after January

1, 2024, any bona fide residents of the city and any residents of the county who are board of public utilities account holders who occupy their residence may file an application for an ex-emption from all amounts paid to the board of public utilities pursuant to subsection (a) of this section for water and electric on their personal residence. Eligibility for such exemption shall be limited to those persons who are the age of 65 or older on January 1 of the application year or are persons with a disability. Eligibility for such an exemption shall be verified pursuant to the process set out in sections 2-296 and 34-21 of the Municipal Code for applicants for refunds. Eligibility for an exemption under this section 18 shall be verified on an annual basis, and once eligibility is so verified the person shall be eligible until June 1 of the following year. Any funds budgeted to cover the loss of revenues due to persons seeking such exemptions that are remaining at the end of the budget year may not be carried over into the following budget year and shall revert to the city's general fund. In no event shall such funds budgeted for such purpose exceed one million dollars per year. All applications for exemption shall be subject to the Kansas cash-basis law and the normal budget and appropriation process.

**Section 2.** If any provision of this Charter Ordinance or the application thereof to any persons or circumstances is held invalid, such invalidity shall not affect other provisions or application of the Charter Ordinance which can be given effect without the invalid provisions or application and to this end the provisions of this Charter Ordinance are declared to be severable.

Section 3. That original section 18 of Charter Ordinance No. CO-3-02 of the Unified Government of Wyandotte County/ Kansas City, Kansas, be and the same is hereby repealed.

Section 4. This ordinance shall be published once each week for two consecutive weeks in the Wyandotte Echo.

Section 5. This is a Charter Ordinance and shall take effect 61 days after final publication unless a sufficient petition for a referendum is filed and a referendum held on the ordinance as provided in article 12, section 5, subdivision (c)(3), of the Constitution of the State of Kansas, in which case the ordinance shall become effective if approved by a majority of the electors voting thereon.

Section 2. On October 18, 2022, April 13, 2023, and May 18, 2023, the Code Official sent written notices by mail to any owner, occupant, or agent of the owner (the "Notices"). (Exhibit A). The Notices each: (a) explained that certain conditions existing on the Property were in violation of the City Code of the City of Bonner Springs; (b) provided any occupant or agent of the owner with ten (10) days to bring the Property into compliance; (c) gave information about the appeal process; and (d) described the penalties for failure to abate the violations. On the same dates, the Code Official posted the Notices in a conspicuous place on the Property.

Section 3. The occupant, owner, or agent of the owner of the Property has failed or refused to correct the conditions described in the Notices and the same conditions currently exist on the Property. (Exhibit B).

Section 4. No less than ten (10) days after the date this resolution is passed, the Code Official and other agents of the City are hereby authorized to abate the conditions on the Property that are causing the violations, as described in the Notices.

Section 5. All costs incurred by the City related to the notice, preparation of this resolution, and abatement of the conditions causing violations shall be charged against the Property as provided by Section 11-207. Section 6. Despite reasonable diligence, the Code Official is unable

to locate the owner's agent or successor(s) in interest. (Exhibit C). Therefore, as authorized by Section 11-205(c), service of this resolution shall be made by registered mail, by posting a copy in a conspicuous location on the Property, and by publishing a copy once each week for

two (2) consecutive weeks in the official City newspaper. Resolved by the Bonner Springs City Council and signed by the Mayor on this 9th day of October, 2023.

A CHARTER ORDINANCE OF THE CITY OF EDWARDSVILLE, KANSAS EXEMPTING THE CITY OF EDWARDSVILLE FROM THE PROVISIONS OF K.S.A. 12-1651 REGARDING NEWSPAPERS IN WHICH LEGAL PUBLICATIONS MAY BE MADE AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECT.

BE IT ORDAINED BY THE GOV-ERNING BODY OF THE CITY OF

EDWARDSVILLE, KANSAS: SECTION ONE: Exemption. The City of Edwardsville, Kansas (the "City"), by virtue of the powers vested in it by Article 12, Section of the Constitution of the State of Kansas, hereby elects to exempt itself from and make inapplicable to it Section 12-1651, Kansas Statutes Annotated, which statute applies to the City but is not uniformly applicable to all cities, and thereby provides substitute and additional provisions on the same subject as set forth in this Charter Ordinance.

SECTION TWO: Substitute and Additional Provisions. The Governing Body shall designate from time to time by resolution one or more newspapers and/ or the City's designated website http://www.edwardsvilleks.org/ as the official newspaper(s) of the City for publication of legal notices, advertisements, or publications of any kind which may be required to be published in the official city newspaper by the laws of the State

of Kansas or of the City. SECTION THREE: Currently Designated Official City Newspaper. Any newspaper that has been designated as an official City newspaper as of the effective date of this Charter Ordinance shall continue to be an official City newspaper unless or until such time as the Governing Body shall adopt a resolution

SECTION FOUR: Publication of Ordinance. This Charter Or-dinance shall be published in its entirety once each week for two (2) consecutive weeks in the official City newspaper. SECTION FIVE: Effective Date

This Charter Ordinance shall take effect 61 days after final publication unless a sufficient petition for a ref-erendum is filed and a referendum held on the Charter Ordinance as provided in Article 12, Section 5, subsection (c)(3) of the Constitution of the State of Kansas, in which case this Charter Ordinance shall become effective if approved by a majority of the electors voting thereon.


