Updated Land Bank Policy Considered

Kansas City, KS – During the March 4th, Economic Development and Neighborhood and Community Development standing committee meeting, Land Bank Manager Jud Knapp presented proposed changes to the Unified Government's Land Bank policy. This proposal comes after 16 months of direct community engagement with over 318 total community members across multiple bilingual events, as well as collaboration with multiple Unified Government Departments, Elected Officials, and other stakeholders.

With a total of 4,297 land bank parcels available throughout Wyandotte County, this proposal seeks to address community concerns to decrease the number of vacant land bank parcels owned by the Unified Government and increase the tax base.

"This proposed policy amendment clearly states our goal to not be in the Land Bank business," said Gunnar Hand, Director of Planning and Urban Design. "It provides the flexibility necessary to accelerate these properties going into private hands while optimizing more equitable outcomes."

Proposed policy changes include allowing yard extensions for butting property owners. The proposal also incorporates the community's interest in land bank parcels being used for personal and community gardens, as well as urban farms for growing sustainable food in Wyandotte County.

The event occurs on April 5 & 6 from 8 AM to 12 PM at Indian Springs, 47th & Orville, Kansas City, KS 66102.

Visitors need to show proof of Wyandotte County residency with something displaying their name and address, like a driver's license or utility bill.

Items accepted include electronics recycling, mattresses, furniture, general appliances, fixtures, microwaves, freezers, televisions, and more.

For televisions, computer screens, flat screens, and monitors, the following fees are charged:

- * CRT Computer Screens, \$40
- * LCD/Flat Screen TVs, \$20
- * CRT TVs, \$40

Cash only. Exact change is required. For the complete list of accepted electronics recycling, visit wycokck.org/DumpsterDays.

Items that cannot be accepted include:

- * All household hazardous waste
- * Paint
- * Refrigerators
- * Yard & storm debris waste
- * Batteries
- * Food waste
- * Medical waste
- * Glass & plastics recycling
- * Construction or demolition material
- * Any item from businesses, non-profits, or other commercial entities

These items will be turned away at the event, so remember not to bring them!

For yard waste, storm debris, and glass or paper recycling, residents may use the Recycling & Yard Waste Center at 3241 Park Drive, Kansas City, KS 66102, at no charge.
