Governor Kelly Announces More than \$76M Investment by Marvin, Creating 600 Jobs in Kansas City, Kansas

TOPEKA – Governor Laura Kelly announced that Marvin, a premium manufacturer of windows and doors, has selected Kansas City, Kansas, as the future home of its latest manufacturing facility. Marvin is investing \$76.5 million to build a 400,000-square-foot facility in the Scannell 435 Logistics Center.

Upon completion in 2025, Marvin anticipates employing approximately 100 team members in full-time positions across its manufacturing, fabrication, and assembly divisions to produce the company's industry-leading fiberglass window and door solutions. With progressive annual growth, Marvin expects to employ a 600-person workforce in Kansas City by 2028.

The following state, federal and local tax incentives (collectively, the "Incentives") are anticipated to apply within the proposed STAR Bond Project District: (i) sales tax and revenue (STAR) bonds issued pursuant to the STAR Bonds Financing Act; (ii) tax increment financing pursuant to K.S.A. 12-1770 et seq., as amended; (iii) community improvement district financing pursuant to K.S.A. 12-6a26 et seq., as amended; and (iv) industrial revenue bonds issued pursuant to K.S.A. 12-1740 et seq., as amended; provided, however, that the foregoing statement is made solely for the purpose of complying with KSA.12 17,165(a(5)and not for the purpose of granting. Approving, or committing to grant of approve any such Incentives. The Governing Body's consideration of any specific request for one or more of the Incentives, and the approval of any such request, shall be by separate proceedings

conducted pursuant to the statutes referenced above.
Section 6. At the public hearing, the Governing Body of the City will consider findings necessary for the establishment of the proposed STAR Bond Project District.

Section 7. This Resolution shall also be conspicuously provided at a prominent location on the first page of the website

of the City.
Section 8. The City shall, and the officers, employees and agents of the City are hereby authorized and directed to, take such action as may be necessary or desirable to carry out and comply with the intent of this Resolution, including the execution and delivery of the Funding Agreement (the "Funding Agreement"), by and between the City and the Developer, in the form now on file with the City Clerk, which Funding Agreement relates to the Developer's requests for the Incentives described in Section 5 above.


