Let Go of the Anchor

Imagine you are swimming while holding a heavy anchor which is pulling you under water. What would you do? Of course you would let go of the anchor to keep from drowning. Maintaining your grip on the anchor would lead to certain disaster.

With your survival at stake, you wouldn't hesitate to drop the anchor. Yet, in life there are issues you are hanging onto which are drowning you. Anger, hate, bitterness, resentment, and

grudges are all anchors pulling you to the bottom. Trying to change circumstances outside of your control also drags you to the bottom.

The problem is that from a young age you have become accustomed to holding on to anchors. The potential damage is not readily recognized because there doesn't appear to be any immediate threat. Furthermore, there is a tendency to pick up and hold onto additional anchors. Then in response

to the weight increasing to unmanageable levels, you tend to tighten your grip rather than letting go.

There are several reasons for this self-destructive behavior. First of all, you don't realize you are actually carrying an anchor. Instead, you have become conditioned to believing that your feelings are the result of what others are doing to you, not what you are doing to yourself. Since you are not aware of the anchor you're carrying, letting go of it is never even

considered an option.

Another reason for not letting go is the false belief that your negative feelings are somehow detrimental to the person you blame. This thinking implies that when you are angry, bitter or upset, the person responsible for your feelings is in some way harmed by your anchor. This logic makes as much sense as believing the weight you are carrying is making someone else tired.

Trying to change someone else is another anchor to let go of. This endeavor leads to never ending frustration. A person can change if they want to, but you cannot make them do it. Although you don't have any control over the actions of others, you do have control over your response.

When you persist in attempting to get others to change, your anchor grows in weight, pulling you

down deeper and deeper. Your grip tightens as you get even more determined to force changes. This is a doomed scenario which typically tears relationships apart.

Let go of this anchor by recognizing people for who they are. Deal with them on this level. Put your energy into your response to their actions. Just because someone acts doesn't mean you have to react.

Continually being offended and taking things personally is yet another anchor. Becoming upset never improves a situation. True freedom is attained through the realization that it really doesn't matter what other people think, say, or do.

In order to let go of the anchor, you must be aware of the fact that you are holding onto one. Accomplishing this requires you to constantly monitor your

emotional state. Your goal is an awareness of how you are feeling and why.

Understanding this cause and effect relationship enables you to recognize when you are holding onto an anchor. Through this approach, you will find you are holding onto anchors more frequently than you realized. Just let go each time you grab onto an anchor.

You are now in the process of changing a lifelong habit. Don't make any excuses for holding onto the anchor. Never say to yourself "I can't let this go." Letting it go is essential for your mental and physical well-being.

Governor proclaims April as Safe Digging Month

TOPEKA—Governor Laura Kelly has issued a proclamation declaring April as Kansas Safe Digging Month. The proclamation, in concurrence with National Safe Digging Month, reminds Kansans to call 811 before starting any outdoor digging projects.

The Kansas Corporation Commission, Kansas 811, Kansas utilities and Governor Kelly are encouraging excavators and homeowners to call 811 before they begin digging projects to prevent injuries, property damage, and inconvenient outages. Nationwide, 25 percent of damages reported are caused by the failure of the professional excavator or homeowner to call 811 before digging according to the Common Ground Alliance's most recent damage information reporting tool (DIRT).

Dialing 811 connects callers to Kansas 811, which notifies the appropriate utility companies of the intent to dig. Calls are taken 24 hours a day, seven days a week. Locate requests can also be made online at www.kansas811.com. Excavators and homeowners are required to make a request at least two working days prior to beginning a digging project. Professional locators are sent to the digging site to mark the approximate locations of underground lines with flags or spray paint. Once lines have been accurately marked, digging can begin.

Every digging project, no matter how large or small, requires a call to 811. There is no charge to have utility lines marked. The depth of utility lines vary and there may be multiple lines in a common area. Some utility lines are buried only a few inches below the surface, making them easy to strike during shallow digging projects. Installing a mailbox, landscaping, putting in a fence, and building a deck are all examples of digging projects that necessitate a call to 811.

ORDINANCE NO. 2567

AN ORDINANCE MAKING FINDINGS AND ESTABLISHING A STAR BOND PROJECT DISTRICT WITHIN THE CITY OF BONNER SPRINGS, KANSAS PURSUANT TO K.S.A. 1217.160 ET SEQ., AS AMENDED (118TH & STATE STAR BOND DISTRICT).

WHEREAS, pursuant to K.S.A. 1217.160 et seq. and L. 2023, Ch. 82 of the State of Kansas, all as amended (collectively, the “STAR Bonds Financing Act”), the City of Bonner Springs, Kansas (the “City”), is authorized to assist in the development and redevelopment of eligible areas within and without the City in order to promote, stimulate and develop the general and economic welfare of the State of Kansas and its communities;

WHEREAS, pursuant to the STAR Bonds Financing Act, the Governing Body of the City adopted Resolution No. 2024-03 on February 26, 2024 (the “Resolution”), finding and determining that it is desirable to encourage the development and redevelopment of certain real property within the City generally located at the southwest corner of the intersection of State Avenue and North 118th Street and to consider the establishment of a STAR bond project district at such location (the “STAR Bond Project District,” as further described herein);

WHEREAS, the Resolution provided for a notice of a public hearing considering the establishment of the STAR Bond Project District to be given in accordance with the STAR Bonds Financing Act and that said public hearing would be held on April 8, 2024;

WHEREAS, notice of the public hearing was duly given in accordance with the STAR Bonds Financing Act;

WHEREAS, on April 8, 2024, the Governing Body of the City conducted a public hearing on the proposed STAR Bond Project District;

WHEREAS, the Kansas Secretary of Commerce has determined that the proposed STAR Bond Project District is an “eligible area” in that it is a major amusement park area, as such terms are defined in the STAR Bonds Financing Act, in accordance with the requirements of the STAR Bonds Financing Act; and

WHEREAS, the proposed STAR Bond Project District does not include any real property which has been a part of another STAR bond project district established under the STAR Bonds Financing Act;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BONNER SPRINGS, KANSAS AS FOLLOWS:

Section 1. The STAR Bond Project District is within the boundaries identified by the Resolution and published in the notice of the public hearing. The legal description and sketch delineating the STAR Bond Project District are set forth in Exhibits A and B attached to this Ordinance and incorporated herein by reference.

Section 2. The Governing Body of the City hereby finds and determines that the STAR Bond Project District proposed to be developed is a “STAR bond project” as defined in K.S.A. 1217.162 and amendments thereto.

Section 3. The STAR bond project district plan for the STAR Bond Project District, which is a preliminary plan that identifies all of the proposed STAR bond project areas and identifies in a general manner all of the buildings, facilities and improvements that are proposed to be constructed or improved in each STAR bond project area, is attached hereto as Exhibit C to this Ordinance and incorporated herein by reference.

Section 4. The following state, federal and local tax incentives (collectively, the “Incentives”) are anticipated to apply within the STAR Bond Project District: (i) sales tax and revenue (STAR) bonds issued pursuant to the STAR Bonds Financing Act; (ii) tax increment financing pursuant to K.S.A. 121770 et seq., as amended; (iii) community improvement district financing pursuant to K.S.A. 12-6a26 et seq., as amended; and (iv) industrial revenue bonds issued pursuant to K.S.A. 12-1740 et seq., as amended; provided, however, that the foregoing statement is made solely for the purpose of complying with K.S.A. 1217.165(c) (1)(C) and not for the purpose of granting, approving, or committing to grant or approve any of such Incentives. The Governing Body's consideration of any specific request for one or more of the Incentives, and the approval of any such request, shall be by separate proceedings conducted pursuant to the statutes referenced above.

Section 5. The Governing Body of the City hereby establishes the STAR Bond Project District in compliance with the STAR Bonds Financing Act.

Section 6. The STAR Bond Project District may be terminated by the Governing Body at any time by passage and publication of an ordinance; provided that following the execution and delivery of a redevelopment agreement or agreements by the City entered into between the City and an entity or entities with rights to develop property within the STAR Bond Project District, the termination of the STAR Bond Project District may be limited by the terms and conditions of such agreement or agreements.

Section 7. Nothing contained in this Ordinance shall obligate the City to approve any STAR bond project plan within the STAR Bond Project District.

Section 8. This Ordinance shall take effect and be in full force from and after its passage by the Governing Body of the City and publication in the official City newspaper. This Ordinance, including the attached exhibits and any other public documents considered at the public hearing on the establishment of the STAR Bond Project District, shall also be conspicuously posted or linked to a prominent location on the first page of the website of the City.

ORDINANCE NO. 2569

An Ordinance to approve a Special Use Permit for Ad Trend Inc., SUP-02-24; located at 14110 Minnesota Avenue. This Special Use Permit is a revision to the original SUP-05-23; it is to allow for the installation of a digital display on the currently approved sign.

Be it ordained by the Governing Body of the City of Bonner Springs, Kansas:

SECTION I: That the Official Zoning Map be amended to indicate a Special Use Permit for Ad Trend, Inc.; approved under SUP-02-24 allowing for the installation of a digital display on the currently approved sign.

The approval of SUP-02-24 is subject to the following eleven (11) conditions:

1. All requirements of the currently approved SUP-05-23 shall apply where applicable.

2. Provide a copy of an approved Sign Permit from the KDOT, Bureau of Right of Way, Outdoor Advertising, along with one (1) set of signed and sealed construction plans reflecting the the installation of the digital display and a building permit application to the Planning Department for the City Planner and Building Officials review and approval;

3. The digital sign may not contain or display flashing, intermittent or moving lights, including animated or scrolling advertising.

4. The images appearing on said digital display must remain in a fixed position for a minimum of eight (8) seconds. (KDOT)

5. If a message is changed electronically, it must be accomplished within an interval of two seconds or less; (KDOT)

6. The sign is not placed within 1,000 feet of another automatic changeable facing sign on the same side of the highway, with the distance being measured along the nearest edge of the pavement and between points directly opposite the signs along each side of the highway; (KDOT)

7. If the sign is a legal conforming structure it may be modified to an automatic changeable facing sign upon compliance with these standards and approval by the department. A nonconforming structure shall not be modified to create an automatic changeable facing sign; (KDOT)

8. The sign contains a default design that will freeze the sign in one position if a malfunction occurs (KDOT)

9. The revocation of the Special Use Permit may occur for a violation of the Unified Development Ordinance as provided in Chapter 2; Section 2.03.B.3.d of the Zoning Ordinance or violation of any or all of the conditions set out in the Special Use Permit; and

10. The Special Use Permit to be valid for an indefinite period of time unless:

- a. The subject property is sold, or
b. The operation of such use by the owner designated in the permit is discontinued for more than 12 months.

11. Special Use Permit may be revoked by the Governing Body for violation of and/or non-compliance with the Municipal Code of Ordinances of the City of Bonner Springs, Kansas.

Section II: This ordinance shall be in full force and effect after passage and publication in the official city newspaper.

An Ordinance to approve a Special Use Permit for the Country Stampede allowing for overnight camping on private property. SUP-01-24 will allow for camping to occur on property owned by the Unified Government of Wyandotte County (Azura Amphitheater) and the Agricultural Hall of Fame

Be it ordained by the Governing Body of the City of Bonner Springs, Kansas:

SECTION I: That the Governing Body approve the special use permit allowing for overnight camping on private property.

The approval of SUP-01-24 is subject to the following seven (7) conditions:

1. All information provided by the applicant in the "Country Stampede Camping Site Plan for Bonner Springs, KS" shall be adhered to.

2. A "Camp Host" shall be present at each camping location entrance for the duration of the event.

3. All spaces shown on the plan shall be labeled, with wayfinding signs provided.

4. The site(s) shall be returned in the condition in which they were provided to the applicant, all temporary trash receptacles shall be emptied and removed, any temporary structures shall be removed, all temporary restroom facilities shall be removed, and general site clean-up shall occur.

5. The Special Use Permit shall be valid for the 2024 edition of the Country Stampede, June 27th through the 29th and is contingent

upon revisions to the Camping Ordinance (Ord. 1774)

Section II: Article 3. Camping Permits; Section 12-3059(c) Permits shall read:

(c) No camping permit shall be issued for a term longer than 72 hours, nor shall any permit be issued which would allow recreational vehicles, motor homes, camp trailers or other such items to be parked on a public park, public street or public right-of-way for purposes of camping.

Section III: This ordinance shall be in full force and effect after passage and publication in the official city newspaper.
