Keep Water Safety Top of Mind this Boating Season Safe Kids Kansas, the U.S. Coast Guard Auxiliary and the Kansas Department of Wildlife and Parks provide tips for families during National Safe Boating Week

TOPEKA – With almost 100 different kinds of boats – from kayaks to canoes to motorboats – many Kansans will be having a great time on the water this year. Governor Laura Kelly has declared May 18-24 Safe Boating Week in Kansas, and Safe Kids Kansas, the U.S. Coast Guard Auxiliary and the Kansas Department of Wildlife and Parks want to remind families to take extra steps to keep kids safe out on the water.

Safe Boating Week is an annual educational campaign, coordinated by the National Safe Boating Council (safeboatingcouncil.org) that runs the week prior to Memorial Day.

Drowning is the third leading cause of unintentional injury-related death among Kansas children. Wearing a life jacket improves your odds of surviving a boating accident by 80 percent. In 2022, 75 percent of all fatal boating accident victims in the U.S.

drowned, and of those who drowned, 85 percent were not wearing a life jacket. During National Safe Boating Week, we want to remind all parents of a few simple things they can do to keep their kids safe on a boat and that starts with wearing life jackets.

“Drowning can happen quickly and silently,” said Cherie Sage, State Coordinator for Safe Kids Kansas. “It’s important for children to wear life jackets when they are in or around open water and for

adults to actively supervise children, giving them your full attention.”

Follow these safety tips to keep your family safe while boating:

1. Take a boating safety course. Gain valuable knowledge and on-water experience in a boating safety course with many options for novice to experienced boaters. Visit cgaux.org/boating/.

2. Always wear a life jacket. Adults and children should always wear a properly fitted life jacket approved by the U.S. Coast Guard while on boats or around open bodies of water. Children ages 12 and under are required by law to wear a life jacket at all times on any watercraft, including paddleboats and

kayaks. Older children and adults should set a good safety example for everyone and wear their life jackets, too.

3. Supervise kids in and around water. When there are several adults present and children are swimming, use a Water Watcher card to designate an adult as the Water Watcher for a certain amount of time (such as 15-minute periods) to prevent lapses in supervision. Download a Water Watcher card here.

4. Educate your children about swimming. Every child is different, so enroll children in swimming lessons when you feel they are ready. Teach children skills such as how to tread water and float. Kids should only swim in areas designated for swimming. Teach children that

swimming in open bodies of water is different than a swimming pool. They need to be aware of uneven surfaces, river currents, undertow and changing weather.

5. Learn Water Rescue Skills. We know you have a million things to do but learning CPR should be at the top of the list. Knowing CPR and other water rescue skills will give you tremendous peace of mind. Contact the Red Cross or your local hospital for information about classes.

6. Watch the weather. Always check the forecast before heading out on the water. Know that weather can change quickly, so have a weather radio or weather app that you can check. If the weather starts to change, head to shore immediately.

Governor Kelly Announces April Total Tax Collections Nearly 8.0% Above the Estimate

TOPEKA – Governor Laura Kelly today announced that total tax collections for April were \$1.42 billion. That is \$101 million, or 7.7%, more than the monthly estimate. Total tax collections are up 9.6% from April 2023.

“These revenue numbers underscore how important it is to provide responsible tax relief now,” Governor Laura Kelly said. “I remain committed to cutting taxes in a fiscally responsible, comprehensive manner that doesn’t jeopardize the progress we’ve made.”

“The overage for April is largely due to the fact that we are processing 63,000 more ‘balance due’ checks from taxpayers this year than we were at the same time last year,” Secretary of Revenue Mark Burghart said. “A combination of two additional processing days and recently upgraded check remittance technology at the Department of Revenue have allowed payments to be processed faster and much more efficiently.

Secretary Burghart went on to say, “the spike in processed payments for April is really just a carrying forward of payments that would normally be processed in May. As a result, individual income tax receipts for May will likely be lower than the estimate.”

Individual income tax collections were \$740.3 million in April 2024. That is \$91.0 million, or 14.0%, more than the estimate, and up 24.7% from April 2023.

Corporate income tax collections were \$338.2 million last month, which is \$6.3 million, or 1.9%, more than estimates. It does, however, reflect a 4.5% drop from corporate income tax collections at this same time last year.

Combined retail sales and compensating use tax receipts were \$295.1 million, which is \$3.1 million, or 1.1% more than the estimate but down \$13.5 million, or 4.4%, from April 2023.

The Consensus Revenue Estimating group met on April 19 to revise estimates for fiscal years 2024 and 2025.

Housing is a Building Block of Recovery

We often talk about how recovery is a journey, not a destination. But what building blocks have to be in place for us to even take the first step on that journey? You might think about having a support system, being willing to ask for help and holding hope that recovery is possible.

All of those things are true. But what about having a roof over your head?

We know from Maslow's Hierarchy of Needs that we first need to meet our basic needs for survival – things like food, water and shelter – before we can meet our needs for safety, belonging, self-esteem and self-actualization. The instability and uncertainty associated with housing insecurity can heighten our levels of stress, anxiety, and depression. That instability can put recovery out of reach.

In Wyandotte County, the average life expectancy varies by 20 years, depending on where you live. That is due in part to the shortage of safe, affordable housing units in our community. When we talk about affordable housing, that means that someone is putting no more than 30 percent of their income toward their rent or mortgage. Currently, the fair market rent for a 1-bedroom apartment in downtown Kansas City, Kansas is \$1,002 per month. That is unattainable for many people. Consider someone who is living on disability income. They receive just over \$900 per month. What safe, affordable housing options do they have?

Too many people in Wyandotte County are living with either the stress of roughly half of their income going toward housing expenses or the stress of being homeless. We also have individuals who are being discharged into homelessness following inpatient psychiatric care. We must do better. Housing is stability. And stability is necessary for recovery. When you do not have a stable living environment, that can disrupt your routines, your connections to your support system and access to the resources and treatment needed for recovery.

A number of Wyandotte County organizations are working together to develop a long-term housing strategy for those who are low income, houseless and/or living with a behavioral health challenge. As in Bergen County, New Jersey, where chronic homelessness has been eradicated, we believe that Wyandotte County can achieve functional zero homelessness.
