# Joseph (Joe) E. Steineger Jr., 90, of Kansas City, Kansas, passed away on June 8, 2024.

A visitation was held on Tuesday, June 11, 2024, at Maple Hill Funeral Home. A Holy Eucharist Service took place on Wednesday, June 12, 2024, at St. Paul's Episcopal Church in Kansas City, Kansas. Burial followed at Highland Park Cemetery. Joseph was born on March er, Sr. and Tessa Faye Munday in Kansas City, Kansas. He graduated from Washington High School in 1952. Shortly after, he met Gloria Irene Krump, and they married in 1954. They enjoyed 45 years of marriage and together raised four children: Joseph (Jenny) Steineger III, Kathie Steineger, Christy Haycraft, and David Steineger.

Joseph was a lifelong member of St. Paul's Episcopal Church. He was also a dedicated and accomplished farmer. cultivating over 3,000 acres a season. His exceptional contributions to agriculture led to his induction into the Agriculture Hall of Fame, where he also served on the board. Joseph was actively involved in several organizations, including The Lions Club, Shriners, Jaycees, and the National Antique Tractor Pullers Association, along with many other civic organizations. He was recognized as the Young Farmer of the Year and Outstanding Man of the Year.

Joseph's commitment to community service was unwavering. He served on the Turner School Board for 35 years and the Kansas State School Board. His leadership extended to public office, where he served as the Mayor of Kansas City from 1987 to 1995.

Joseph E. Steineger Jr. will be remembered for his dedication to his family, his church, his community, and his remarkable contributions to agriculture.

### CHARTER ORDINANCE NO. 2024-02

A CHARTER ORDINANCE EXEMPTING THE CITY OF ED-WARDSVILLE, KANSAS, FROM THE FIRST CLAUSE OF K.S.A. 14570 RELATING TO BONDS FOR PUBLIC IMPROVEMENTS AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECT.

WHEREAS, the City of Edwardsville, Kansas (the "City"), is a city of the second class organized and existing under the laws of the State of Kansas;

WHEREAS, pursuant to Article 12, Section 5, of the Constitution of the State of Kansas, cities are empowered to determine their local affairs and government except for legislative enactments applicable uniformly to all cities.

WHEREAS, K.S.A. 14-570 applies to the City but is not uniformly applicable to all cities in that it applies only to cities of the second class: and

WHEREAS, the Governing Body of the City hereby determines that it is in the best interest of the City to exempt the City from the first clause of K.S.A. 14-570 and to provide substitute and additional provisions on the same subject; provided, however, the City by this action is not exempting itself from the second clause of K.S.A. 14-570;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERN-ING BODY OF THE CITY OF EDWARDSVILLE, KANSAS, AS FOLLOWS

SECTION 1. THE CITY, BY THE POWER VESTED IN IT BY ARTICLE 12, SECTION 5, OF THE CONSTITUTION OF THE STATE OF KANSAS, HEREBY ELECTS TO EXEMPT ITSELF FROM AND MAKE INAPPLICABLE TO IT THE FIRST CLAUSE OF K.S.A. 14-570 AND PROVIDE SUBSTITUTE AND ADDITIONAL PROVISIONS AS HEREINAFTER SET FORTH IN THIS CHARTER ORDINANCE; PROVIDED, HOWEVER THAT THE CITY IS NOT BY THIS AC-TION EXEMPTING ITSELF FROM THE SECOND CLAUSE OF K.S.A. 14-570. THE FIRST CLAUSE OF K.S.A. 14-570 FROM WHICH THE CITY IS EXEMPTING ITSELF IS REFLECTED IN THE STRUCK THROUGH TEXT BELOW. THE SUBSTITUTE AND ADDITIONAL PROVISIONS WHICH THE CITY IS PROVIDING ARE REFLECTED IN THE ITALICIZED TEXT BELOW.
