Joe Maderak Remembered

I remember the first time I met Joe Maderak. It was the spring of 1985. It was a Tuesday afternoon when Joe came into my office unannounced.

Those who knew me knew not to bother me on a Tuesday. That was the day I went to press with my weekly newspaper, The Wyandotte West.

Joe had a petition he wanted me to sign. The petition called for the formation of a new organization which would later be called Business West.

I tried everything I could do to discourage Joe from distracting me. I finally signed the petition. Later that week, when I wasn't so busy, I decided that having such an organization may not be such a bad idea.

The motivating reason for Joe's organizational efforts was the firing of the first permanent City Administrator, Myron James Medin. Voters had approved a change in the form of city government which allowed for a professional administrator to run city government. Joe, and many other Kansas City residents, were upset about the firing. Hiring a City Administrator had given people hope.

During the ensuing several years I got to know Joe very well. He was the first Chairman of the Board of Directors of Business West and I was the first Board Secretary. The organization took a stand on several issues, not being afraid because an issue was controversial.

I was sadden to learn that Joe died June 15 at the age of 101. He was a successful businessman having founded Maderak Construction in 1952 with his wife, Katie. He was also an active board member of the Builders Association.

Joe and his family were active members of St. Patrick's Roman Catholic Church. He also was a lifelong member of the Lions Club; he received a lifetime membership for more than 50 years of service.

Joe served in the U.S. Navy in the South Pacific during World War II. I was pleased to have known and worked with Joe.

A RESOLUTION OF THE GOVERNING BODY OF THE CITY OF BONNER SPRINGS, KANSAS DETERMINING THAT THE CITY IS CONSIDERING ESTABLISHING A REINVESTMENT HOUSING INCENTIVE DISTRICT WITHIN THE CITY AND ADOPTING A PLAN FOR THE DEVELOPMENT OF HOUSING AND PUBLIC FACILITIES IN SUCH PROPOSED DISTRICT, ESTABLISHING THE DATE AND TIME OF A PUBLIC HEARING ON SUCH MATTER, PROVIDING FOR NOTICE OF SUCH PUBLIC HEARING, AND REPEALING RESOLUTION NO. 2024-05 OF THE CITY (120 ON OAK APART-MENTS REINVESTMENT HOUSING INCENTIVE DISTRICT).

WHEREAS, the Kansas Reinvestment Housing Incentive District Act, K.S.A. 12-5241 et seq., as amended or supplemented (the "Act"), authorizes any city incorporated in accordance with the laws of the State of Kansas (the "State") to designate reinvestment housing incentive districts ("RHIDs") within such city; and

WHEREAS, prior to such designation the governing body of such city shall conduct a housing needs analysis to determine what, if any, housing needs exist within its community; and

WHEREAS, after conducting such analysis, the governing body may adopt a resolution making certain findings regarding the establishment of an RHID and containing a legal description of property to be contained therein, a map of the existing parcels of real estate in the proposed district, and a statement of findings and determinations set forth in K.S.A. 12-5244(a); and

WHEREAS, after publishing such resolution at least once in the official newspaper of the city, the governing body of such city shall send a certified copy thereof to the Secretary of Commerce of the State (the "Secretary") requesting that the Secretary review the resolution and advise the governing body whether the Secretary agrees with the finding contained therein; and

WHEREAS, if the Secretary agrees with such findings, the governing body may proceed with the establishment of an RHID within such city, and adopt a plan for the development or redevelopment of housing and public facilities in the proposed district; and

WHEREAS, the City of Bonner Springs, Kansas (the "City"), constitutes a "city" as defined in the Act; and

WHEREAS, the Governing Body of the City previously performed a Housing Needs Analysis dated June 2022 (the "Analysis");

WHEREAS, the Governing Body of the City adopted Resolution No. 2023-10 on May 22, 2023, which made certain findings relating to the need for financial incentives for the construction of quality housing within the City, declared it advisable to establish an RHID pursuant to the Act, and authorized the submission of such Resolution and the Analysis to the Secretary in accordance with the provisions of the Act; and

WHEREAS, the Secretary, pursuant to a letter dated June 6, 2023, authorized the City to proceed with the establishment of an RHID pursuant to the Act (as more particularly described herein, the "District"); and

WHEREAS, the City has caused to be prepared a plan for the development or redevelopment of housing and public facilities in the proposed District in accordance with the provisions of the Act (the "Plan"); and

WHEREAS, the Plan includes:

1. The legal description and map required by subsection (a) of K.S.A. 12-5245, and amendments thereto;

2. The existing assessed valuation of the real estate in the proposed District listing the land and improvement values separately; 3. A list of the names and addresses of the owners of record

of all real estate parcels within the proposed District; 4. A description of the housing and public facilities project or projects that are proposed to be constructed or improved in the District, and the location thereof;

5. A listing of the names, addresses and specific interests in real estate in the proposed District of the developers responsible for development of the housing and public facilities in the proposed District:

6. The contractual assurances, if any, the Governing Body has received from such developer or developers, guaranteeing the financial feasibility of specific housing tax incentive projects in the proposed District; and

7. A comprehensive analysis of the feasibility of providing housing tax incentives in the proposed District as provided in the Act, which shows that the public benefits derived from such District will exceed the costs and that the income therefrom, together with all public and private sources of funding, will be sufficient to pay for the public improvements that may be undertaken in such District which identifies any other sources of public or private funds are to be used to finance the improvements; and

WHEREAS, the Governing Body of the City proposes to continue proceedings necessary to create the District, in accordance with the provisions of the Act, and adopt the Plan, by the calling of a public hearing on such matters.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERN-ING BODY OF THE CITY OF BONNER SPRINGS, KANSAS, AS FOLLOWS:

Section 1. Proposed Reinvestment Housing Incentive District. The Governing Body hereby declares intent to establish within the City an RHID to be known as "The 120 on Oak Apartments Reinvestment Housing Incentive District" (the "District"). The District is proposed to be formed within the boundaries of the real estate legally described in Exhibit A attached hereto, and shown on the map depicting the existing parcels of land attached hereto as Exhibit B. A list of the names and addresses of the

A summary of the contractual assurances by the developer and the comprehensive feasibility analysis is contained in Exhibit E attached hereto.



Housing Facilities

The housing facilities include the development of approximately 93 multi-family units, consisting primarily of studio, 1and 2-bedroom units, as determined by developer. Such units will be constructed in a single multi-family apartment building generally located west of the intersection of Oak Street and Front Street (Kansas Highway 32) in the District, with surface parking generally located west of such multi-family apartment building in the District.

Public Facilities

The public facilities to be constructed or improved in the District are limited because the infrastructure, including streets, sewer, water, and utilities, already exists to serve the District.

Pursuant to K.S.A. 125249(a)(12)(A), it is intended that revenues from the District will be used, primarily or exclusively, to reimburse the costs of the housing facilities rather than the public facilities because:

\* The proposed housing facilities financed with District revenues will be exclusively for residential use; \* The District is an "existing lot" to the extent that it is com-

prised of a single existing tax parcel; and

\* The infrastructure, including streets, sewer, water, and utilities, has been in existence for at least 10 years.

Heartland Housing Partners, LLC, has conducted a study to determine whether the public benefits derived from the District will exceed the costs and whether the income from the District. together with other sources of funds, will be sufficient to pay for the public improvements to be undertaken in the District. The analysis estimates the property tax revenues that will be generated from the District, less existing property taxes, to determine the revenue stream available to reimburse the Developer for a portion of the costs of the improvements advanced by the Developer. The estimates indicate that the revenue realized from the District, together with other available sources of funds, will be adequate to pay the costs of the improvements described in Exhibit D above. No special obligation bonds of the City will be issued to finance the improvements described in the Plan; instead, the improvements will be financed on a pay-as-you-go basis as described in the Development Agreement.

SECTION 1. THE CITY. BY THE POWER VESTED IN IT BY ARTICLE 12, SECTION 5, OF THE CONSTITUTION OF THE STATE OF KANSAS, HEREBY ELECTS TO EXEMPT ITSELF FROM AND MAKE INAPPLICABLE TO IT THE FIRST CLAUSE OF K.S.A. 14-570 AND PROVIDE SUBSTITUTE AND ADDITIONAL PROVISIONS AS HEREINAFTER SET FORTH IN THIS CHARTER ORDINANCE: PROVIDED, HOWEVER THAT THE CITY IS NOT BY THIS AC-TION EXEMPTING ITSELF FROM THE SECOND CLAUSE OF K.S.A 14-570. THE FIRST CLAUSE OF K.S.A. 14-570 FROM WHICH THE CITY IS EXEMPTING ITSELF IS REFLECTED IN THE STRUCK THROUGH TEXT BELOW. THE SUBSTITUTE AND ADDITIONAL PROVISIONS WHICH THE CITY IS PROVIDING ARE REFLECTED IN THE ITALICIZED TEXT BELOW. AND THE SECOND CLAUSE OF K.S.A. 14-570 FROM WHICH THE CITY IS NOT EXEMPTING ITSELF IS REFLECTED IN THE PLAIN TEXT BELOW. THE TEXT OF K.S.A 14570.
