## Celebrate Safely This Independence Day with Tips from the Experts

TOPEKA – The Kansas Department of Health and Environment (KDHE), Office of the State Fire Marshal (KSFM) and Safe Kids Kansas would like to share some important safety tips to ensure that all Kansans have a safe and fun Independence Day this year.

In 2023, there were a total of 146 injuries caused by fireworks in Kansas. The person igniting the firework

was most likely to be injured, and the hands were the most common body part to be injured. Over half of the injuries that occurred from fireworks that happened on July Fourth were from burns. There was a 43 percent increase in reported injuries from 2022.

With the exception of two age groups all saw an increase. Injuries more than doubled for the 14-18 year old age group. The highest incidents

of injuries were caused by mortars or artillery fireworks and other fireworks like parachutes, fountains and spinning items. This data was collected through voluntary reporting from Kansas hospitals and administered by the Office of the State Fire Marshal.

“Sparklers are often thought to be safe for young children, but they account for roughly one-quarter of all emergency room visits related to fire-

works,” Cherie Sage, director of Safe Kids Kansas, said. “Children should not light fireworks, including sparklers, which burn at a temperature hot enough to melt glass. We encourage parents to let their little ones use glow sticks instead of sparklers and leave the rest to grownups.”

Grilling is another favorite part of many summertime gatherings. Make sure grills are used outdoors only, away from the home and deck railings, and out from under eaves and overhanging branches. Keep children and pets away from the grill area and never leave your grill unattended. Clean your grill regularly to prevent grease fires.

Here are some tips to keep your celebrations safe:

- Have adults supervise children and pets around grills and fireworks.
- Designate a child-free safety zone around grills and areas where fireworks are being lit.
- Store fireworks in a cool, dry place.
- Adults should only handle fireworks. Consider giving children glow sticks, which also help you see little ones after dark.
- Have a water supply ready, such as a bucket of water or garden hose.
- Dispose of used fireworks carefully, as they may reignite.
- Keep a first-aid kit available and nearby.
- Ignite fireworks outdoors on a flat surface.
- Light only one firework at a time.
- Never stand over fireworks when lighting or hold-

ing a firework in your hand when lighting the fuse and wear eye protection.

- Never try to re-light or pick up fireworks that have not ignited fully.
- Never attempt to make your own fireworks.

Bottle rockets are illegal and M80 type of “fireworks” are considered explosives, and it is a felony in Kansas to possess, manufacture or use, as well as being extremely dangerous. The use or sale of these banned fireworks and explosives is considered a

crime under Kansas law. It is also illegal in Kansas to shoot fireworks on or under any vehicle, on any public roadway, within 50 feet of a fireworks stand or where fireworks are stored, and at gas stations or any place liquid gas – including propane – is stored.

Always refer to the local ordinances as to whether fireworks are allowed in your area as well as what types. Some cities or counties have restricted dates/times or types of fireworks that may be sold or discharged.

## Buzzed Driving Is Drunk Driving

Motorists in Kansas will see and hear numerous Buzzed Driving Is Drunk Driving safety messages the week of the 4th of July holiday to stress the importance of never drinking and driving.

The Kansas Department of Transportation, the Drive To Zero (DTZ) Coalition and local law enforcement agencies are joining together in this effort. High intensity enforcement will occur over the holiday week along with safety reminders from July 1-7.

Impaired driving is both illegal and dangerous. “Besides being illegal, driving impaired puts anyone in your vehicle or your path at risk for a crash resulting in serious injury or death,” said KDOT Behavioral Safety Manager Gary Herman. “And with many Independence Day activities taking place at night, impaired drivers increase the risks even more.”

According to KDOT, 65 people lost their lives in 2,140 alcohol-related crashes recorded in 2023. This marks a decrease from 2022, when 95 alcohol-related fatalities occurred.

Drivers with a blood alcohol concentration (BAC) above Kansas’ limit of .08% are considered alcohol-impaired by law. However, a small amount of alcohol is considered buzzed driving because it can affect a person’s ability to drive safely.

“Simply planning ahead by designating a sober driver can be the difference in avoiding a DUI and potential jail time, let alone placing lives in jeopardy,” Herman said.

ORDINANCE NO. O-65-24

AN ORDINANCE AUTHORIZING THE CREATION OF THE KAW RIVER BRIDGE COMMUNITY IMPROVEMENT DISTRICT IN THE UNIFIED GOVERNMENT OF WYANDOTTE COUNTY/KANSAS CITY, KANSAS; AUTHORIZING THE MAKING OF CERTAIN PROJECT IMPROVEMENTS RELATING THERETO; APPROVING THE ESTIMATED COSTS OF SUCH PROJECT IMPROVEMENTS; AND LEVYING A COMMUNITY IMPROVEMENT DISTRICT SALES TAX WITHIN SUCH DISTRICT.

WHEREAS, K.S.A. 12-6a26 et seq. (the “Act”) authorizes the governing body of any city or county to create community improvement districts to finance projects within such defined area of the city or county and to levy a community improvement district sales tax within the community improvement district to finance projects; and

WHEREAS, a petition dated April 10, 2024 (the “Petition”) was filed with the Clerk of the Unified Government of Wyandotte County/Kansas City, Kansas (the “Unified Government”), proposing the creation of the Kaw River Bridge Community Improvement District (“CID”) under the Act with the imposition of a two percent (2.00%) CID sales tax (the “CID Sales Tax”) in order to pay the costs of projects as described in the Petition (the “Projects”); and

WHEREAS, the Petition was signed by the required number of owners of record, whether resident or not, as required by the Act; and

WHEREAS, the Unified Government intends to create the CID and to levy the CID Sales Tax as requested in the Petition; and

WHEREAS, the Act provides that prior to creating any community improvement district and imposing a community improvement district sales tax, the governing body shall, by resolution, direct and order a public hearing on the advisability of creating such community improvement district and the construction of such community improvement district projects therein, and to give notice of the hearing by publication at least once each week for two (2) consecutive weeks in the official Unified Government newspaper and by certified mail to all property owners within the proposed community improvement district, the second publication to be at least seven (7) days prior to the hearing and such certified mail sent at least ten (10) days prior to such hearing; and

WHEREAS, the Board of Commissioners of the Unified Government (the “Governing Body”) adopted Resolution No. R-24-24 on May 30, 2024 (the “Resolution”) directing that a public hearing on the proposed CID within the Unified Government be held on June 27, 2024, declaring its intent to impose the CID Sales Tax, and requiring that the Unified Government Clerk provide for notice of such public hearing as set forth in the Act; and

WHEREAS, the Resolution was mailed (by certified mail) to all property owners within the proposed CID on June 13, 2024, and published once each week for two (2) consecutive weeks in The Wyandotte Echo, the official Unified Government newspaper, on June 6 and 13, 2024; and

WHEREAS, on June 27, 2024, the Governing Body conducted a public hearing on the advisability of the proposed CID; and

WHEREAS, the Governing Body hereby finds and determines it to be advisable to create the CID and set forth the boundaries thereof, authorize the Projects relating thereto, approve the estimated costs of the Projects and approve the method of financing the same, all in accordance with the provisions of the Act.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE UNIFIED GOVERNMENT OF WYANDOTTE COUNTY/KANSAS CITY, KANSAS:

SECTION 1. Creation of Community Improvement District; Boundaries. The Governing Body hereby finds and determines that it is advisable to create, in accordance with the provisions of the Act, the CID within the Unified Government to be referred to as the Kaw River Bridge Community Improvement District. A legal description of the boundaries of the proposed CID is set forth on Exhibit A, attached hereto and incorporated by reference herein. A map generally outlining the boundaries of the proposed CID is attached as Exhibit B, attached hereto and incorporated by reference herein.

SECTION 2. Authorization of Community Improvement District Projects and Estimated Costs.

(a) The general nature of the Projects is approved as follows:

The redevelopment of the historic Rock Island Railroad Bridge (the “Bridge”), located on both sides of and over the Kansas (Kaw) River. The general nature of the Projects is to promote economic development within the CID, all of which shall be accomplished by providing community improvement district financing in accordance with the Petition, the Act, and the UG’s policy, to finance the demolition, construction, design, maintenance, and procurement of certain improvements, costs, and services within the CID, including but not limited to: property acquisition, infrastructure and site work related items, streets, sidewalks, parking improvements, buildings, facilities, tenant improvements, landscaping, stream corridor improvements, utilities, signage, lighting, art, other cultural amenities, soft costs of the project (including interest), and the UG’s administrative costs in establishing and administering the CID, and any other items permitted to be financed within the CID under the Act. Without limiting the generality of the foregoing, the Projects may include the design, development and construction and of an innovative trail, public gathering space and commercial facilities on the Bridge, consisting of a variety of components and unique offerings, including: (a) a public pathway across the Bridge to connect the West Bottoms area of Kansas City, Missouri to existing levee trails along the west side of the Kansas River and associated amenities; (b) multi-purpose commercial space located on the Bridge consisting of an open-air coffee roastery/shop and bar, one or more restaurants, and retail; (c) unique common spaces

for public gathering and viewing, events and entertainment; and (d) an outdoor food hall, including commercial kitchens for local chefs to serve visitors.

(b) The total estimated total costs of the Projects are \$14,989,212.55 plus any financing costs which are eligible pursuant to the Act, and any fees or expenses of the Unified Government in connection with the Projects.

SECTION 3. Method of Financing.

(a) It is proposed that the Projects be financed through a combination of private equity, private debt, certain grant moneys received from the State of Kansas, and available funds of the Unified Government in an amount not to exceed \$2,471,678.80 (plus interest and subject to modification by the UG), and pay-as-you-go CID financing (including the CID Sales Tax), as defined in the Act and that certain Kaw River Bridge Cooperative and Development Agreement dated as of June 7, 2021 (together with any and all amendments thereto, the “Agreement”) between the UG and Flying Truss, LLC, a Missouri limited liability company.

The CID Sales Tax shall be two percent (2.0%) on the sale of tangible personal property at retail or the rendering or furnishing of services which are taxable pursuant to the Kansas Retailers’ Sales Tax Act (K.S.A. 79-3601 et seq.) within the CID, such CID Sales Tax to commence on October 1, 2024, or such other date as shall be approved by ordinance of the Governing Body, and to continue for a maximum term of twenty-two (22) years.

(b) There will be no CID special assessments.

(c) There will be no issuance of CID bonds.

SECTION 4. Effective Date. This Ordinance shall take effect and be in full force from and after its passage by the Governing Body and publication once in the official newspaper of the Unified Government pursuant to applicable law.

SECTION 5. Recording. The Clerk shall file a certified copy of this Ordinance with the Register of Deeds of Wyandotte County, Kansas.


