Speeding can be costly and wreck lives

The chance of death or serious injury doubles for every 10 mph over 50 mph a vehicle travels, and speeding is a factor in almost one-third of all traffic fatalities nationwide.

These facts from the National Highway Traffic Safety Administration show why the Kansas Department of Transportation, the Drive To Zero Coalition and law enforcement agencies across the state are working together to increase awareness that "Speeding Wrecks Lives."

Beginning July 22 and running through Aug. 11, motorists can expect increased safety messaging as well as increased enforcement for speeding to urge drivers to obey posted speed limits and help reduce crashes and fatalities.

"These enhanced safety efforts are about saving lives,"

said KDOT Behavioral Safety Manager Gary Herman. "Drivers should follow the posted speed limits to reduce risk to themselves, occupants in their car and those around them. Speeding catches up with you."

In 2023 in Kansas, 79 people lost their lives in speed-related crashes, which is a reduction from 2022. However, the 2,085 people who were seriously injured

It takes about 221 feet to stop a vehicle traveling 50 mph. Increase the vehicle speed to 80 mph, and it takes about 460 feet to stop, according to NHTSA.

"With more space needed to stop and less time to

respond, the chances of a crash and crash severity while speeding are greatly increased," said Herman. "Drivers offer various excuses for speeding, but there is no good excuse."

Compounded crash risks when speeding include:

• Increased chance of losing control of the vehicle.

- Reduced effectiveness of seat belts and child safety seats
- Increased stopping distance needed.
- Increases chance for serious injury or death due to speed and mass impact.
- Increases fuel consumption and vehicle costs for the driver.

Combating Elder Abuse

Elder abuse is the intentional mistreatment or harming of an adult over age 60. This abuse can take many forms – physical, emotional, sexual, and financial exploitation, as well as neglect. In the United States, an estimated 1 in 10 adults over the age of 60 experience some form of abuse each year. That number is likely much higher because elder abuse is often underreported – especially in underserved communities.

Abuse victims typically show emotional and behavioral red flags, such as depression, unusual fear or anxiety, or intentional isolation. Many victims are abused by someone they know or trust. It's important to look for unusual changes in behavior around:

- * Family members.
- * Staff at inpatient facilities.
- * Hired or volunteer caregivers.
- * People in positions of trust like doctors or financial advisors.

You can help make a difference by checking in with older loved ones. The first step to preventing abuse is to look for signs of mistreatment or physical harm, including bruises, burns, and other unexplained injuries.

There may also be signs of neglect such as:

- * Hunger and poor nutrition.
- * Poor appearance or hygiene.
- * Lack of necessary medical aids like glasses or medications that a caretaker should be providing.

There may also be indications of financial abuse, including:

- * Unpaid rent or other bills.
- * Sudden changes to a will.
- * Unusual changes in money management or habits.
- * Large, unexplained financial transactions.
- * Allowing someone new to access bank accounts.

If you suspect that a person is a victim of elder abuse, please report it. If you or someone you care about is in a life-threatening situation, call 911. If you suspect possible abuse – but see no immediate danger – contact:

- * Your local Adult Protective Services at www.napsa-now.org/help-in-your-area.
- * The National Center on Elder Abuse at 1-855-500-3537 (ELDR).

You can also find additional local resources by searching the Eldercare Locator for your community at eldercare.acl.gov/Public/index.aspx.
