A winning game plan: drive sober this Super Bowl

The Super Bowl is a time for people to gather and cheer on their favorite team. Before the game kicks off on Feb. 9 in New Orleans, the Kansas Department of Transportation reminds everyone to make a game-winning plan to drive sober.

Alcohol-related crashes are preventable. Preliminary KDOT data shows that 69 people lost their lives in alcohol-related crashes in

Kansas in 2024, and nearly 1,000 others were injured. Drive sober and save lives.

“Drinking and driving is a choice,” said KDOT Behavioral Safety Manager Gary Herman. “Doing so can cause injury or death to the driver, passengers and others on the road. Even one alcoholic drink could affect your ability to drive, and the consequences could be life-altering.”

Before the celebrations begin, create a plan.

* Hosts should provide non-alcoholic beverages and make sure guests have a safe way to get home.

* If fans choose to drink, make advance arrangements to use a designated driver, a rideshare or a cab.

* If a friend is leaving a Super Bowl party impaired, take the keys.

* If you see an impaired

driver on the road, contact law enforcement.

“Remember, in addition to affecting other lives, a DUI can cost thousands of dollars and impact your job as well as the rest of your life,” Herman said.

El Super Bowl es un momento para que la gente se reúna y anime a su equipo favorito. Antes de que el juego comience el 9 de febrero en Nueva Orleans, el Departamento de Transporte de Kansas recuerda a todos que deben hacer su plan de juego ganador para conducir sobrios.

Los accidentes relacionados con el alcohol se pueden

prevenir. Datos preliminares del KDOT muestran que 69 personas perdieron la vida en accidentes relacionados con el alcohol en Kansas en 2024 y cerca de otras 1.000 resultaron heridas. Conduzca sobrio y salve vidas.

“Beber y conducir es una opción,” dijo Gary Herman, gerente de Seguridad Conductual del KDOT. “Hacerlo puede causar lesiones o la muerte al conductor, los pasajeros y otras personas en la carretera. Incluso una bebida alcohólica podría afectar su capacidad para conducir y las consecuencias podrían alterar su vida.”

Antes de que comiencen las celebraciones, haga un plan.

* Los anfitriones deben proporcionar bebidas sin alcohol y asegurarse de que

los invitados tengan una manera segura de regresar a casa.

* Si los fanáticos eligen beber, haga arreglos por adelantado para usar un conductor designado, un viaje compartido o un taxi.

* Si un amigo sale de una fiesta del Super Bowl bajo los efectos del alcohol, tome las llaves.

* Si ve a un conductor bajo los efectos del alcohol en la carretera, comuníquese con policía.

“Recuerde, además de afectar otras vidas, un DUI puede costarle miles de dólares e impactar su trabajo, así como el resto de su vida,” dijo Herman.

National Unclaimed Property Day

Treasurer Steven Johnson urges all residents to take part in National Unclaimed Property Day on Saturday, February 1, a day dedicated to raising awareness about billions of dollars in unclaimed property being held by state governments across the country. Whether it's an abandoned bank account, an uncashed check, or forgotten insurance proceeds, unclaimed property can be found in nearly every community.

“I encourage everyone to take a few moments to see if there are funds out there waiting to be claimed,” said Treasurer Johnson. “This day is a reminder that reuniting people with their money is a priority for my office. We want everyone to know that even small amounts can make a big difference.” Unclaimed property typically includes assets from dormant bank accounts, unpaid wages, life insurance policies, utility refunds, safe deposit box contents, and more. Through the state's unclaimed property program, Treasurer Johnson's office works diligently to safeguard these funds until rightful owners step forward.

How to Check for Unclaimed Property:

1. Visit unclaimedproperty.ks.gov — This official website by the Kansas Treasurers Office allows you to search for unclaimed property.
2. Provide your basic information — Searches only require minimal information, typically your name and county of residence.
3. Submit a claim if a match is found — Follow the instructions for providing proof of ownership and identification.

Since unclaimed property is reported to the state by businesses and financial institutions, the amounts held can range from a few dollars to thousands. Many residents and businesses are surprised to discover they have missing or forgotten funds, so checking regularly is a wise practice.

Subject to the Notice of Bond Sale dated on or about February 14, 2025 (the "Notice"), bids for the purchase of the above-referenced bonds (the "Bonds") of the Unified Government of Wyandotte County/Kansas City, Kansas (the "Issuer") herein described will be received until 11:00 a.m., Central Time (the "Submittal Hour"), on FEBRUARY 27, 2025 (the "Sale Date"). Bond Details. The Bonds will consist of fully registered bonds in the denomination of \$5,000 or any integral multiple thereof. The Bonds will be dated March 27, 2025, and will become due on August 1 in the years as follows:

SUMMARY: The USDA, Rural Development - Rural Business Service (RBS)has made a Finding of No Significant Impact (FONSI) with respect to a request for possible financial assistance to Unified Government of Wyandotte County/Kansas City, Kansas for construction of the Kaw Point Biosolids and Modernization Improvements Project in Wyandotte County, Kansas.

SUPPLEMENTARY INFORMATION: Unified Government of Wyandotte County/Kansas City, KS proposes to implement the Kaw Point Biosolids and Modernization Improvements Project at the Kaw Point Wastewater Treatment Plant (WWTP) in Kansas City, KS. The project includes modification of existing buildings and construction of new buildings at the existing Kaw Point WWTP to process sewage and manufacture fertilizer and nutrient alternatives (Class B solids) for land application. The alternatives are discussed in the Kaw Point Biosolids and Modernization Improvements Project EA. The RBS has reviewed and approved the EA for the proposed project.

The availability of the EA for public review was announced via notice in the following newspaper: The Wyandotte Echo on October 31, 2024, and November 7, 2024. A 30-day comment period was announced in the newspaper notices. The EA was also available for public review at the USDA Rural Development office and website as well as Unified Government of Wyandotte County/Kansas City, Kansas office. No comments were received relative to the proposed development.

Based on its EA, commitments made by Unified Government of Wyandotte County/Kansas City, Kansas, and public comments received, RBS has concluded that the project would have no significant impact (or no impacts) to water quality, wetlands, floodplains, land use, aesthetics, transportation, or human health and safety.

The proposed project will have no adverse effects on resources listed or eligible for listing on the National Register of Historic Places. The Agency has also concluded that the proposed project is not likely to affect federally listed threatened and endangered species or designated critical habitat thereof. The proposed project would not disproportionately affect minority and/or low-income populations.

LEGAL NOTICE

No other potential significant impacts resulting from the proposed project have been identified. Therefore, RBS has determined that this FONSI fulfills its obligations under the National Environmental Policy Act, as amended (42 U.S.C. 4321 et seq.), the Council on Environmental Quality Regulations (40 CFR §§ 1500-1508), and USDA Rural Development's Environmental Policies and Procedures (7 CFR Part 1970) for its action related to the project.

RBS is satisfied that the environmental impacts of the proposed project have been adequately addressed. RBS's federal action would not result in significant impacts to the quality of the human environment, and as such it will not prepare an Environmental Impact Statement for its action related to the proposed project.
