Lawmakers Support National Historic Landmark Designation of Quindaro Townsite

Congressman Derek Schmidt (KS-02) recently led fellow Kansas City area Representatives Sharice Davids (KS-03) and Emanuel Cleaver (MO-05) in encouraging the National Park Service to designate the Quindaro Townsite in Wyandotte County as a National Historic Landmark. The Kansas City, Kansas site served as a critical entry point for anti-slavery settlers and a sanctuary for

those escaping bondage via the Underground Railroad prior to and during the U.S. Civil War.

“Quindaro is a meaningful part of our region, state, and country’s history,” Congressman Schmidt said. “Recognizing the site as a National Historic Landmark will provide the designation necessary to properly preserve the legacy of this important historical site. I’m proud to lead my fellow

Kansas City area lawmakers in this effort.”

“Quindaro is a powerful part of Kansas’ history in the fight for freedom and equality, but for too long, local preservation efforts of this important site have lacked much-needed resources,” Representative Davids said. “I’m proud to work with Representatives Schmidt and Cleaver to ensure this site receives the recognition and protection it deserves

through a National Historic Landmark designation.”

“The Quindaro Townsite is a vital piece of U.S. history that demonstrates our national commitment to liberty and self-determination, which ought to be celebrated and shared with future generations,” said Congressman Cleaver. “Just as I was proud to introduce the bipartisan Quindaro Townsite National Historic Landmark Act with Reps. Schmidt and Davids, I’m once again honored to advocate for the designation of Quindaro as a National Historic Landmark, preserving this important chapter in America’s story until the end of time.”

Founded in 1857, Quindaro emerged as a beacon for Free-State advocates during the turbulent “Bleeding Kansas” era. Strategically located along the Missouri River, it served as a critical entry point for anti-slavery settlers and a sanctuary for those escaping bondage via the Underground Railroad. The town’s establishment was a collaborative effort among the Wyandot Nation, New England abolitionists, and African American settlers, exemplifying a unique and harmonious multicultural alliance during a period marked by division and conflict.

Beyond its pivotal role in the anti-slavery movement, Quindaro became a nucleus for post-Civil War African American advancement. The establishment of the Quindaro Freedman’s School, later known as Western University, marked

a significant milestone as the first Black school west of the Mississippi River. Institutions like Douglass Hospital further underscored the town’s commitment to education and healthcare within the African American community.

Archaeological excavations have unveiled a wealth of artifacts, offering invaluable insights into the

daily lives of Quindaro’s diverse inhabitants. The site’s preserved foundations and structures provide a tangible connection to this rich history. Recognized on the National Register of Historic Places since 2002, Quindaro’s significance has been further acknowledged through its designation as a National Commemorative Site in 2019.

The agency announced last week that Olivia and Liam were the most popular baby names in the U.S. How does Kansas compare to the rest of the country? Check out Social Security’s website, www.ssa.gov/oact/babynames/, to see the top national baby names for 2024 and see where your name ranks now and over the past 100 years.

Social Security began compiling the baby names list in 1997, with names dating back to 1880. Each year, the list reveals the effect of pop-culture on naming trends. In addition to each state’s top baby names (and names for U.S. territories), Social Security’s website has a list of the 1,000 most popular boys’ and girls’ names for 2024 and the fastest rising girls’ and boys’ names.

Most parents apply for their child’s Social Security number (SSN) at birth, during their hospital stay. Social Security Commissioner Frank Bisignano encourages families to take this vital step in ensuring valuable protection for any benefits their children may be eligible for in the future.

An SSN is needed to claim a child as a dependent for income tax purposes or to open a bank account in the child’s name and buy savings bonds. More information on getting a child’s Social Security number and card is provided in Social Security Numbers for Children.

An Ordinance to approve a Special Use Permit for APAC – Kansas, Inc. under SUP-01-25. This Special Use Permit is to allow for the continued operation of the Bonner Springs Quarry for Energy Resource Extraction as allowed for in the Unified Development Ordinance at 1800 S. 122nd Street and 800 S. 118th Street.

Be it ordained by the Governing Body of the City of Bonner Springs, Kansas:

SECTION I: That the Official Zoning Map be amended to indicate a Special Use Permit for 1800 S. 122nd and 800 S. 118th Streets; approved under SUP-01-25 allowing for the continued operation of the Bonner Springs Quarry for Energy Resource Extraction as allowed by the Unified Development Ordinance.

The approval of SUP-01-25 is subject to the following twenty-three (23) conditions:

1. Future expansions of surface mining operations and additions to the site not identified on the Site Plan will require submission of a revised Special Use Permit and Phasing Plan. Improvements not shown on the Phasing Plan are not a part of this approval;

2. Subsurface mining shall be allowed via this Special Use Permit, prior to this action; detailed plans, including but not limited to; engineering, internal layout and other detailed plans or studies as requested by the City shall be provided prior to work commencing.

3. * All subsurface mining operations shall maintain, at a minimum, the current setbacks listed upon the approved phasing plan. Access to underground mining operations from Phase I, Stages I or II shall not be required to adhere to the internal setbacks indicated on the plan, in order to reach Phase I, Stage III.

4. The applicant shall revise and update the existing approved storm water reports for Phase I, Stage III. These shall be submitted to the city within six (6) months of the approval of this Ordinance; and subsequently approved by the City Engineer and constructed by the applicant as deemed necessary;

5. The hours of operation shall be as follows, subject to the filing of written public complaints on any of the individual operations:

Removal of Rock – 6 a.m. to 6 p.m. – Monday through Saturday;
Rock Crushing – 6 a.m. to 6 p.m. Monday through Saturday; Blasting – 9 a.m. to 3 p.m. – Monday through Friday; and

Any blasting after 3 p.m. may be permitted only to meet Federal Blasting Requirements or for emergency situations with notification to and approval by the City Manager or his/her designated employee.

6. Plans and specifications shall be submitted on each occurrence for each temporary use of a portable crusher, portable asphalt plant and portable concrete ready-mix plant. Such plans, specifications and operation of the temporary uses on each individual basis shall conform to all federal, state and local requirements necessary to obtain any necessary permits prior to operation, but shall not require a revision to the Amended Special Use Permit. Hours of operation shall conform to those observed by the quarrying operation;

7. Reports of all inspections required by the Kansas Department of Health and Environment, U.S.

Environmental Protection Agency, the State Board of Agriculture-Division of Water Resources, the Bureau of Mines, including insurance inspections or any other agency requirements shall be provided to the City as they occur and are received;

8. The applicant shall conform to all dust, noise, air or any other environmental regulations applicable and shall conform to the stated methods of control and operation contained in the application and Environmental Impact Study. These shall include, but not be limited to, the watering of internal roadways for dust control and all applicable dust control methods relating to the use of rock crushing equipment;

9. Quarrying equipment shall not be visible from adjoining properties or from K-32 Highway;

10. All reclamation areas identified on the prior special use permit(s) and approved Reclamation Plan, including the southwest portion of the property and the east central portion of the property shall be maintained to blend with the terrain surrounding the quarry. The trees in the reclamation areas shall be properly maintained and all dead, dying or diseased trees shall be replaced as soon as possible to coincide with a planting season(s);

11. The lowest elevation of the surface mine shall not be less than 735 feet above mean sea level;

12. Once per calendar year, the City will conduct an inspection of the operations. City authorized personnel shall be allowed on the site to conduct these inspections or to participate in any other inspections deemed necessary by the City or any other local, state or federal agency;

13. An annual report on the quarry operation shall be provided no later than March of each year following the approval of the amended Special Use Permit. The Annual Report shall include the status of the quarrying operation and the progress of reclamation;

14. An annual blasting permit shall be obtained from the City and violation of the blasting requirements may constitute justification to revoke the Special Use Permit;

15. All trucks leaving the site shall be covered to eliminate the potential of spillage of rock on public roadways or damage to other property; and

16. Storm inlets on the east side of 121st Street shall be cleaned out to prevent accumulated silt from proceeding further into storm sewer system.

17. Public right of way that exists on the property currently may be vacated via appropriate action through the UDO. The public right of way shall be rededicated at a future time that allows for the extension of S. 122nd St or Steventon Drive through the property.

18. The site shall not be utilized in the future as a municipal or private landfill.

19. The applicant shall contract with a local weather service to provide wind speed/direction and temperature inversion information to ensure that the timing of blasting occurs when the weather conditions are the most conducive to reduced blasting effects such as air pressure vibrations and dust issues for the surrounding residents.

20. No blasting for surface extraction shall occur within

one-thousand (1000') feet of a dwelling not owned or managed by the applicant.

Said dwellings must be within one-thousand (1000') feet of the established setbacks.

22. The revocation of the Special Use Permit may occur for a violation of the Unified Development Ordinance or violation of any or all of the conditions set out in the Special Use Permit;

23. The term of the Special Use Permit shall be for a ten (10) year period of time and only for Phase I, Stages II, III and Phase II, unless said operation ceases for a period longer than 6 months or the property is sold.

Section II: All other ordinances or parts of ordinances in conflict with the provisions of this ordinance shall and are hereby repealed.

Section III: This ordinance shall be in full force and effect after passage and publication in the official city newspaper.
