## National WWI Museum and Memorial announces Local Discount for Summer 2025

*Residents in a six-county radius will receive a \$10 all-access ticket from June 1-Sept. 1.*

The National WWI Museum and Memorial announced a new summer special exclusively for locals. From June 1 - Sept. 1, 2025, local residents in the six counties surrounding Kansas City can save on admission with a special \$10 ticket and discover everything that's changed in the Museum and Memorial since the start of the Gallery Refresh project.

The Gallery Refresh con-

cluded on Memorial Day weekend with the completion of Encounters, a multi-media presentation where guests come face-to-face with 16 individuals and their real stories crafted from diaries, letters and photos. Other projects over the three-year journey to reinvigorate the Museum and Memorial, include the new Lower Level and Open Storage Center and updates to the Main Gallery, like

14 new interactive screens, three new films, new lighting and special effects, updated trenches, an authentic replica field hospital and much more. Additionally, the exterior grounds and buildings have undergone extensive cleaning and preservation work (including replacing over 520,000 pounds of limestone) to maintain this national museum and memorial for generations to come.

"Kansas Citians have been stewarding the Museum and Memorial for almost 100 years and should be first in line to see the extensive upgrades that their support has made possible," said Matthew Naylor, President and CEO of the National WWI Museum and Memorial.

The \$10 all-access ticket is available for residents of Johnson, Wyandotte and Leavenworth counties in Kansas and Jackson, Clay and Platte counties in Missouri. Residents must present proof of residency with valid ID: one ticket per ID with the exception of children and youth. This offer is available in-person at the Ticketing

Counter only.

## A-List Actor Turns Lens on Caregivers Local

Kansas City PBS announces a slate of programming to complement the premiere of Caregiving, a new PBS documentary from celebrity actor Bradley Cooper. The documentary focuses on the work of often unpaid caregivers as they provide support to loved ones with illnesses and disabilities. To support the national conversation with local voices, Kansas City PBS is rolling out a televised town hall, a series of digital shorts and additional local reporting in June that dives into the state of Kansas City's local care system.

Caregiving will be available to stream on the PBS app starting Tuesday, May 27, and airs on Channel 19.1 on Tuesday, June 24, at 8 p.m. Kansas City PBS' televised town hall, , airs on Thursday, June 26, at 7 p.m. Flatland, Kansas City PBS' nonprofit newsroom, will examine individual stories of local caregivers in a series of short videos available at [flatlandkc.org](http://flatlandkc.org) starting on June 5.

Narrated by award-winning actress Uzo Aduba, Caregiving brings audiences into the daily experiences of several family and professional caregivers across the U.S. as they share the realities associated with providing full-time care and the often-complicated challenges and emotions that are part of the care relationship.

To better understand the state of caregiving in Kansas City, Week in Review host Nick Haines will moderate a panel of local experts and caregivers in The Invisible Army town hall. In partnership with the Kansas City Public Library, the panel will feature representatives from local organizations that prioritize caregivers.

Flatland will take audiences a step further by pulling back the veil on the intimate lives of our city's caregivers in a new series of digital shorts from filmmaker John McGrath. The series follows the story of a child born with a disability and his journey with his family to find the tools he needs to have a better life. Plus, the series will provide resources to help caregivers cope with an aging population that will soon outnumber individuals 18 and under for the first time in history.

**CHARTER ORDINANCE NO. 2025-02**

A CHARTER ORDINANCE EXEMPTING THE CITY OF EDWARDSVILLE, KANSAS, FROM THE PROVISIONS OF K.S.A. 12-1220 THROUGH 12-1230, RELATING TO THE ESTABLISHMENT, MAINTENANCE, AND FUNDING OF PUBLIC LIBRARIES, AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS.  
 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF EDWARDSVILLE, KANSAS:  
 SECTION 1. AUTHORITY. This ordinance is enacted pursuant to the provisions of Article 12, Section 5 of the Kansas Constitution, which empowers cities to determine their local affairs and government by charter ordinance.  
 SECTION 2. The City of Edwarsville, Kansas, by virtue of this charter ordinance, hereby elects to exempt itself from and make inapplicable all provisions of K.S.A. 12-1220 through 12-1230, and any amendments thereto, which apply to this city but are not uniformly applicable to all cities.  
 SECTION 3. SUBSTITUTE PROVISIONS. The City of Edwarsville may, by charter or ordinary ordinance, provide for library services as it deems appropriate, including but not limited to; Contracting with other governmental entities or private organizations for library services; Providing library services directly under city management; Discontinuing the levy of a tax specifically for the maintenance of a public library as prescribed in K.S.A. 12-1220 et seq.; or Establishing alternative funding, governance, or operational frameworks for library services.  
 SECTION 4. SEVERABILITY. If any section, clause, sentence, or provision of this ordinance is found to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity shall not affect the remaining portions of this ordinance, which shall remain in full force and effect.
