## KCC schedules public hearings on Evergy's request to raise rates

TOPEKA – The Kansas Corporation Commission (KCC) will hold public hearings in Wichita and Topeka beginning next week to give Evergy Kansas Central customers the opportunity to learn more about the company's rate increase request, ask questions and make comments before the Commission.

Evergy filed an application with the Commission in January seeking a \$196.4 million (8.62%) rate increase. If approved as filed, the new electric rates would take effect in September 2025, resulting in an average monthly increase of \$13.05 for residential customers.

Attendees may participate in person or virtually via Zoom. Those participating virtually must register by noon the day prior to the hearing using the registration links below. In addition, the hearings will be broadcast live and recorded for later viewing on the KCC's YouTube channel. Registration is not required to attend in person or view on YouTube.

To register to participate in the hearing via Zoom, make a public comment online or find additional information on the application, go to the Commission's website ([www.kcc.ks.gov](http://www.kcc.ks.gov)) and click on the "Your Opinion Matters" tab.

The Commission will issue an order on the application on or before September 29, 2025.

## CHARTER ORDINANCE NO. 2025-02

A CHARTER ORDINANCE  
EXEMPTING THE CITY OF ED-  
WARDSVILLE, KANSAS, FROM  
THE PROVISIONS OF K.S.A. 12-  
1220 THROUGH 12-1230, RELAT-  
ING TO THE ESTABLISHMENT,  
MAINTENANCE, AND FUNDING  
OF PUBLIC LIBRARIES, AND  
PROVIDING SUBSTITUTE AND  
ADDITIONAL PROVISIONS.

BE IT ORDAINED BY THE  
GOVERNING BODY OF THE CITY  
OF EDWARDSVILLE, KANSAS:

SECTION 1. AUTHORITY. This  
ordinance is enacted pursuant  
to the provisions of Article 12,  
Section 5 of the Kansas Consti-  
tution, which empowers cities to  
determine their local affairs and  
government by charter ordinance.

SECTION 2. The City of Ed-  
wardsville, Kansas, by virtue of  
this charter ordinance, hereby  
elects to exempt itself from and  
make inapplicable all provisions of  
K.S.A. 12-1220 through 12-1230,  
and any amendments thereto,  
which apply to this city but are not  
uniformly applicable to all cities.

VISIONS. The City of Edwardsville  
may, by charter or ordinary ordi-
