Red Cross to offer new opportunity to help save lives in Greater Kansas City area

People wanting to make a lifesaving difference in the Greater Kansas City area now have the chance to donate blood and platelets at the new American Red Cross Blood Donation Center in Overland Park.

On Friday, June 27, the donation center will begin collecting blood and platelet donations for patients, such as those battling cancer, accident victims, transplant recipients and those living

with sickle cell disease.

This is the first time donors are able to give platelets with the Red Cross in the Greater Kansas City and Northwest Missouri area. Platelets

are the clotting portion of blood and are needed for many reasons, but they are primarily given to cancer patients. These tiny cells have a very short shelf life – just five days from the time they are donated – so there is a constant, often critical, need for new and current donors to give to keep up with hospital demand for platelets.

Having a readily available blood supply is vital for patients whose survival

depends on transfusions. Donating blood is essential to community health, and volunteer donors are the only source of blood for those in need. By making an appointment to give blood or platelets at the Red Cross Blood Donation Center, donors can feel good knowing that they may be helping patients not only in their community, but also their family and friends across the nation.

“From mothers experiencing childbirth complications to those facing trauma situations in the emergency room, many of us may be connected to someone who has relied on lifesaving blood products,” said JoAnn Woody, Executive Director of the Greater Kansas City and Northwest Missouri Cross Region. “The Red Cross is pleased to offer donors this new opportunity to help provide hope, healing and access to treatment for patients in need.”

In addition to the Red Cross Blood Donation Center, individuals will also continue to be able to give blood at Red Cross blood drives across the Greater Kansas City and Northwest Missouri community.

How to donate blood or platelets

Simply download the American Red Cross Blood Donor App, visit RedCrossBlood.org, call 1-800-RED CROSS (1-800-733-2767) or enable the Blood Donor Skill on any Alexa Echo device to make an appointment or for more information. All blood types are needed to ensure a reliable supply for patients. A blood donor card or driv-

er’s license or two other forms of identification are required at check-in. Individuals who are 17 years of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in

generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also have to meet certain height and weight requirements.

Blood and platelet donors can save time at their next donation by using RapidPass® to complete their pre-donation reading and health history questionnaire online, on the day of their donation, before arriving at the blood drive. To get started, follow the instructions at RedCrossBlood.org/RapidPass or use the Blood Donor App.

Blood donation safety precautions

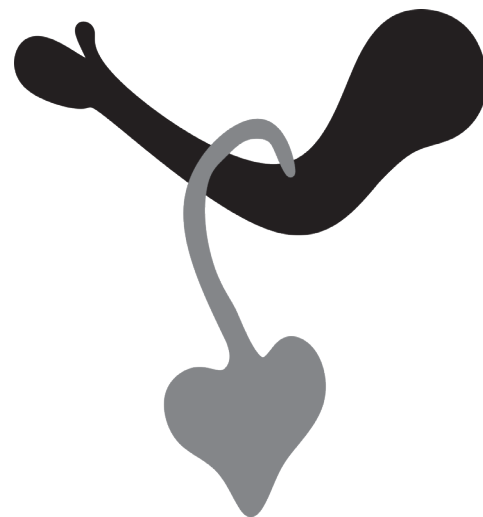
To protect the health and safety of Red Cross staff and donors, individuals who do not feel well or who believe they may be ill with COVID-19 should postpone their donation.

Each Red Cross blood drive and donation center follows the highest standards of safety and infection control, and additional precautions – including

temperature checks, social distancing and face masks for donors and staff – have been implemented to help protect the health of all those in attendance. Donors are asked to schedule an appointment prior to arriving at the drive and are required to wear a face mask while at the drive, in alignment with Centers for Disease Control and Prevention public guidance.

CHARTER ORDINANCE NO. 39

A CHARTER ORDINANCE EX-EMPTING THE CITY OF BONNER SPRINGS, KANSAS FROM THE PROVISIONS OF KSA 12-1697 RELATING TO THE LEVY OF A TRANSIENT GUEST TAX WITH- IN THE CITY AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECT

BE IT ORDAINED BY THE GOV- ERNING BODY OF THE CITY OF BONNERSPRINGS, KANSAS THAT:

SECTION I: The City of Bonner Springs, Kansas, by the power vested in it by Article 12, Section 5 of the Constitution of the State of Kansas, hereby elects to make inapplicable to it, and exempt itself from the provisions of KSA 12-1697 which applies to said city but not uniformly to all cities and to provide substitute provisions on the same subject as hereinafter provided.

SECTION II: In order to provide revenue to promote tourism and conventions, there is hereby levied a transient guest tax of eight (8%) percent upon the gross receipts derived from or paid directly or through an accommodations broker by transient guests for sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel or tourist court location within the City of Bonner Springs, Kansas. The terms used in this ordinance shall be applied as defined in KSA 12-1696 the provisions of which are hereby incorporated herein by reference.

SECTION III: Any transient guest tax levied pursuant to this section shall be based upon the gross rental receipts collected by any business or accommodations broker. The taxes levied pursuant to this section shall be paid by the consumer or user to the business and it shall be the duty of each and every business to collect from the consumer or user the full amount of any such tax, or an amount equal as nearly as possible or prac- ticable to the average equivalent thereto. Each business collecting any of the taxes levied hereunder shall be responsible to paying over the sums to the State Department of Revenue in the manner pre- scribed by K.S.A. 12-1698 and the State Department of Revenue shall administer and enforce the collection of such taxes.

SECTION IV: This ordinance shall be published once each week for two consecutive weeks in the official city newspaper.

SECTION V: This is a Charter Ordinance and it shall take ef- fect on October 1, 2025, unless within sixty (60) days of its final publication a petition signed by a number of electors of the City of Bonner Springs equal to not less than ten (10) percent of the number of electors who voted at the last preceding regular City Election shall be filed in the of- fice of the City Clerk of Bonner Springs demanding an election on the Charter Ordinance, in which case the Charter Ordinance shall become effective only if and when approved by a majority of the electors voting thereon.

SECTION VI: Upon its effective date, this Charter Ordinance shall be recorded by the City Clerk in a book maintained for charter ordinances of the City and shall be filed with the Secretary of the State of Kansas.
