Stock Market Insights

Market Suffers Sharp Selloff as Doubts Rise Over AI Trade and NVIDIA's Future

The neighboring town near where I grew up has an old Missouri Pacific railroad roundhouse. It was already out of use when I was a boy, but it still fascinated me that big steam engines would be driven onto a turntable and rotated around to change directions. There are more tracks today, so it's easier to turn trains around, but chang-

ing directions is still a big deal, maybe even more so when it's an investment change in direction.

Global stock indexes are still reeling from four consecutive days of stock selloffs. The four-day selloff, which began on November 13th, saw the Dow fall 4.5%, its sharpest four-day decline since 1999. Investors are still jittery about whether all this investment in Artificial Intelligence (AI) will pay off in profits. It's clear that investors are worried the AI boom that has

driven markets higher this year might be running out of steam.

Chipmakers like NVIDIA have posted big losses in recent days, with NVIDIA's shares down some 12% from their record high last month, including a 7% one-day loss. Investors are signaling uncertainty about AI stocks, prompting them to pull back some holdings and see how market conditions unfold.

NVIDIA earnings reports are coming out soon, and it has become a macroeconomic event

in and of itself. Investors will not just be listening for NVIDIA's numbers but also for clues about what is happening in the AI economy. This is because NVIDIA is seen as the linchpin for the entire AI industry. The world's most valuable public company has lost some notable shareholders, including Peter Thiel's hedge fund, which sold around \$100 million, and the giant Japanese investor SoftBank, which sold nearly \$6 billion. They weren't just selling a few shares to take some gains; both liquidated their entire positions.

With these prominent investors pulling out of NVIDIA, it could be signaling a change in the AI trade. While we don't know where Peter Thiel is re-deploying that cash, it was interesting to see SoftBank note that it used those proceeds to fund a larger investment in ChatGPT. So, in a sense, it's shifting some of its bets from chips themselves to actual AI applications like ChatGPT. It will be interesting to see where the money flows are going in the AI trade and which stocks benefit. This could very well be the beginning of a change in investment direction away from chipmakers toward more applications. The AI trade will no doubt continue, but we don't know which direction it will take.

This latest round of pullbacks might be investors trimming their bets in the lead-up to NVIDIA's earnings. Although it could be the beginning of investors redirecting towards applications.

With the bar set especially high for NVIDIA's earnings, anything less than a stellar report

and strong future outlook could cause big swings in the markets. It will need to prove to investors that they are essential not only as chipmakers but also to AI applications. Their stock and the AI industry will be riding on its report.

Another interesting thing about that town and the roundhouse is that nearby, trout fishermen from around the world come to catch the elusive McCloud River redband trout. The railroad men in the late 1800s carried some of these unique California trout in milk jugs. However, when the train broke down over Crane Creek, the workers threw them over the bridge before they died. So, because of these events, you can now find McCloud River trout not only in California, but also in the small town of Crane, Missouri.

Sometimes good things happen when you don't change direction too often. We will see if something similar happens when investment directions change.

PETITION FOR DETERMINATION OF PATERNITY

COMES NOW Petitioner, Maria Elizabeth Navarro, by and through her attorney of record Mario J. Moore Ramirez, and for her Petition for Determination of Paternity, pursuant to the Kansas parentage act (K.S.A. 23-2201 through 23-2225), and in support of said Petition, Petitioner states the following:

- 1. That Petitioner, Maria Elizabeth Navarro is the natural mother of the minor child: William Winkel, DOB: September 17, 2017. 2. That Respondent, Curtis Lee Winkel, is the biological father of the minor child. 3. The Petitioners have been residents of the State of Kansas for a period in excess of ninety (90) days next preceding the commencement of this action. 4. The Respondent has been residents of the State of Iowa for a period in excess of ninety (90) days next preceding the commencement of this action, and since February 2021 is nowhere to be found by Petitioner. 5. The minor child, William Winkel, DOB: September 17, 2017, has resided since birth until the present date with Petitioner. 6. Petitioner and Respondent engaged in sexual intercourse with each other, on or about the time of conception of the minor child. 7. Jurisdiction is proper in Wyandotte County as Petitioner has resided in Wyandotte County with the minor child over 90 days prior to filing the Petition for determination of Paternity. 8. This Court is competent to de-

cide child custody matters, and has jurisdiction to make child custody determinations concerning the child. The State of Kansas is the home state of the child at the time of the commencement of the proceeding; and that it is in the best interest of the minor child that this court assume jurisdiction because the child and their parents have significant connections with the State of Kansas. Specifically, Wyandotte County, Kansas, and there is available with the state substantial evidence concerning the child's present and future care, protection, training, and personal relationships.

9. It is in the best interest of the minor child, William Winkel, that the Petitioner be awarded Sole legal and physical custody of the minor child for the following reasons:

- A) That since February 2021, Respondent has not been involved in the minor child's life. B) That since February 2021, Respondent has not called the minor child. C) That since February 2021, Respondent has not visited the minor child. D) That since February 2021, Respondent has not financially assisted the minor child. E) That Respondent is unfit by reason of conduct or condition which renders the parents unable to care properly for the child and the conduct or condition is unlikely to change in the foreseeable future. F) That Respondent has abandoned the minor child. G) It is not in the best interest of the minor child to be in the custody of the Respondent. H) The Petitioner is fit, able and eagerly willing to have sole custody of the minor child. 10. That Respondent, Curtis Lee Winkel should be declared as the natural and biological father, and thereafter, Respondent's rights should be terminated over the minor child, William Winkel.

WHEREFORE, Petitioner prays for an order of this Court Declaring Petitioner, Maria Elizabeth Navarro, to be the natural and biological Mother of the minor child; An order of this Court Declaring Respondent, Curtis Lee Winkel, to be the natural and biological Father of the minor child; Order awarding Petitioner sole legal and sole physical custody of the minor child and designating the minor child's address as the same address of the Petitioner for mailing and educational purposes; and for such other relief as the court deems just and necessary.

That Petitioner is aware that requesting termination of parental rights towards Respondent shall as well terminate any future child support for the minor child and being advised of this, Petitioner still wishes to proceed with termination.

ORDINANCE NO. 2603

AN ORDINANCE AUTHORIZING THE CITY OF BONNER SPRINGS, KANSAS, TO ISSUE ITS INDUSTRIAL REVENUE BONDS (TAXABLE UNDER FEDERAL LAW), SERIES 2025 (SCANNELL BUILDING 3A – LOT 5 PROJECT), IN THE PRINCIPAL AMOUNT NOT TO EXCEED \$56,000,000 FOR THE PURPOSE OF FINANCING THE COST OF ACQUIRING, CONSTRUCTING, EQUIPPING AND FURNISHING A COMMERCIAL FACILITY; AUTHORIZING THE EXECUTION OF CERTAIN DOCUMENTS IN CONNECTION WITH THE ISSUANCE OF THE BONDS (SCANNELL BUILDING 3A – LOT 5 PROJECT).

WHEREAS, the City of Bonner Springs, Kansas (the “Issuer”), is authorized by K.S.A. 121740 et seq., as amended (the “Act”), to acquire, construct, improve and equip certain facilities (as defined in the Act) for commercial, industrial and manufacturing purposes, to enter into leases and leasepurchase agreements with any person, firm or corporation for such facilities, and to issue revenue bonds for the purpose of paying the costs of such facilities; and

WHEREAS, pursuant to Resolution No. 2024-02 of the Issuer adopted on February 26, 2024, as amended by Resolution No. 2024-09 of the Issuer adopted on June 24, 2024 (collectively, the “Resolution of Intent”), the Issuer expressed its intent to issue industrial revenue bonds (Taxable Under Federal Law) in the approximate principal amount of \$56,000,000 for the purpose of financing the costs of acquiring, constructing, equipping and furnishing a warehouse, distribution, and office facility, including real estate, buildings, improvements and equipment (the “Project”), and further authorized the execution of a Payment in Lieu of Tax Agreement (the “PILOT Agreement”) between the Issuer and Scannell Properties #516, LLC, an Indiana limited liability company (“Scannell Properties”), providing for a property tax exemption for the Project financed with industrial revenue bonds, subject to certain conditions; and

WHEREAS, Section 9 of the Resolution of Intent permits Scannell Properties, with written notice to the City, to assign the benefits of the Resolution of Intent; and

WHEREAS, pursuant to the Assignment and Assumption Agreement dated July 17, 2024, and the Notice thereof dated July 25, 2024, Scannell Properties did assign the benefit of the Resolution of Intent to Steamboat Real Estate, LLC, a Delaware limited liability company (the “Company”); and

WHEREAS, the Issuer has found and does find and determine that it is desirable in order to promote, stimulate and develop the general economic welfare and prosperity of the Issuer and the State of Kansas that the Issuer issue its Industrial Revenue Bonds (Taxable Under Federal Law), Series 2025 (Scannell Building 3A – Lot 5 Project), in the principal amount not to exceed \$56,000,000, (the “Bonds”), for the purpose of paying the costs of acquiring, constructing, equipping and furnishing the Project, as more fully described in the Indenture, in the Base Lease and in the Lease hereinafter authorized, and authorizing the Issuer to lease the Project to the Company; and

WHEREAS, the Issuer further finds and determines that it is necessary and desirable in connection with the issuance of the Bonds to execute and deliver (i) a Trust Indenture (the “Indenture”), with U.S. Bank Trust Company, National Association as Trustee, or such other bank designated by the Company and approved by the Mayor (the “Trustee”), prescribing the terms and conditions of issuing and securing the Bonds; (ii) a Base Lease (the “Base Lease”), with the Company under which the Issuer will lease the Project from the Company; (iii) a Lease (the “Lease”), with the Company under which the Issuer shall cause the Project to be acquired, constructed, equipped, furnished and leased to the Company in consideration of payments of Basic Rent and other payments as defined and provided for therein, (iv) a Bond Purchase Agreement providing for the sale of the Bonds by the Issuer to the Company, and (v) the PILOT Agreement (the Indenture, the Base Lease, the Lease, the Bond Purchase Agreement and the PILOT Agreement are referred to collectively herein as the “Bond Documents”);

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BONNER SPRINGS, KANSAS, AS FOLLOWS:

Section 1. Authority to Cause the Project to be Acquired, Constructed, Equipped and Furnished. The Issuer is hereby authorized to cause the Project to be acquired, constructed equipped and furnished all in the manner and as more particularly described in the Indenture and the Lease herein authorized.

Section 2. Authorization of and Security for the Bonds. The Issuer is hereby authorized and directed to issue the Bonds for the purposes set forth in this Ordinance; provided, however, that issuance of the Bonds shall be conditioned upon receipt by the Issuer of a commitment for title insurance and other evidence that any existing litigation regarding the Project does not present a material risk to the Issuer. Issuance of the Bonds shall be conclusive evidence that such condition has been met. The Bonds shall be dated and bear interest, shall mature and be payable at such times, shall be in such forms, shall be subject to redemption and payment prior to the maturity thereof, and shall be issued in the manner prescribed and subject to the provisions, covenants and agreements set forth in the Indenture. The Bonds shall be special limited obligations of the Issuer payable solely from the trust estate established under the Indenture, including revenues from the lease of the Project to the Company. The Bonds shall not be general obligations of the Issuer nor constitute a pledge of the faith and credit of the Issuer and shall not be payable in any manner by taxation.

Section 3. Execution of Bonds and Bond Documents. The Mayor or acting Mayor of the Issuer is hereby authorized and directed to execute the Bonds and deliver them to the Trustee for authentication on behalf of, and as the act and deed of the Issuer, in the manner provided in the Indenture and as provided in this Ordinance. The Mayor or acting Mayor is further authorized and directed to execute and deliver the Bond Documents on behalf of, and as the act and deed of the Issuer, in substantially the forms on file in the office of the City Clerk, with such corrections or

amendments thereto as the Mayor or acting Mayor may approve, which approval shall be evidenced by his or her execution thereof, and to execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the purposes and intent of this Ordinance and the Bond Documents. The City Clerk or the Deputy City Clerk of the Issuer is hereby authorized and directed to attest the execution of the Bonds and the Bond Documents and execute or attest such other documents, certificates and instruments as may be necessary or desirable to carry out the intent of this Ordinance under the Issuer’s official seal.

Section 4. Tax Exemption; Payment in Lieu of Taxes. The Issuer hereby determines that pursuant to the provisions of K.S.A. 79-201a Twenty-Fourth, the Project purchased or constructed with the proceeds of the Bonds is subject to exemption from ad valorem property taxes for ten years commencing the year following the year in which the Bonds are issued, provided proper application is made therefor to the Kansas Board of Tax Appeals. The Issuer further determines that the Project shall be exempt from such taxes for ten years, commencing in the year after the Bonds are issued, subject to an annual payment in lieu of taxes and other terms and conditions of the PILOT Agreement. In making such determination the Governing Body of the Issuer has conducted the public hearing and reviewed the analysis of costs and benefits of such exemption required by K.S.A. 12-1749d. The Company is responsible for preparing such application and providing the same to the City for its review and submission.
