Why a US Naval Blockade of Venezuelan Oil Isn't Driving Crude Higher

Since my kids first got their driver's licenses, we have had a family rule: no car can go below a quarter of a tank of gas. I sold them on this so well that it caused a lot of anxiety in my teenagers, who thought running out of gas was the worst thing in the world. This may be the same anxiety that the Venezuelan government is feeling.

Crude Oil is having a rough

year. It is down almost 24% since last January, after steady selling pressure for the past several months. Crude Oil recently closed at its lowest level in nearly five years, which is bad news for oil investors but good news for consumers. This was before news of President Trump's blockade of sanctioned oil tankers in Venezuela.

The US Navy has now blocked access to all Venezuelan ports. This is the first US blockade since 1962, when President Kennedy enacted a blockade around

Cuba in the Soviet missile crisis.

This is a partial blockade because it appears to exclude Chevron, which is exempt from US sanctions. This comes just days after US forces seized an oil tanker off the coast of Venezuela on December 10. In the week since the seizing of the tanker, the number of ships waiting to call at Venezuelan ports has dropped from 45 to about a dozen, according to marine traffic data.

Seizing the tanker was hurtful, but the blockade is devastating to

the Venezuelan economy.

Right now, Venezuela exports between 750,000 and 950,000 barrels per day. Of that, 150,000 barrels per day come from Chevron, which will continue to flow. So that leaves Venezuela with 500,000 to 800,000 barrels per day that won't be sold. What is important about those barrels is not just the number, but where they were supposed to be sold. More than 80% of those exports were intended for China, which buys sanctioned oil at a heavy discount, making this a broader geopolitical confrontation. China can buy oil somewhere else, but it won't be as cheap as the oil that it gets from Venezuela.

This blockade will severely damage the Venezuelan economy since the country is so dependent on oil revenues. It is estimated that oil accounts for almost 90% of Venezuela's economy. The timing is even worse because its economy is again facing a period of hyperinflation.

Oil prices so far are mostly unaffected by the blockade. The day after the blockade was announced, crude oil was up less than a dollar a barrel, or 2%. Years ago, this would've been a \$5-\$10-per-barrel increase, but because we are in a period of surplus in the oil market, prices are down. This blockade might cause a short-term disruption in the oil market, but it won't affect long-term supplies because other producing countries will offset any global supply losses.

Another factor investors should keep in mind is the China factor. After the Venezuelans themselves, the most negative impact will be to China, which has been enjoying discounted

oil. This disruption in cheap oil could complicate or derail ongoing US/China tariff negotiations.

Though this blockade is historic, it will not be highly harmful to US businesses or the stock market. The global oil surplus and the current low price per barrel will soften any short-term negative effects. Still, investors should be watchful for how it will affect global political tensions and the overall surplus of global crude oil.

A few days ago, my daughter borrowed my truck to go to a Kansas City Chiefs game. Even though she is married and moved out, nothing has changed. When I got in her car, its gas gauge was right at a quarter of a tank, so I filled it up for her. At least gas is cheap these days.

CHARTER ORDINANCE NO. 2025-03

A CHARTER ORDINANCE EX-EMPTING THE CITY OF EDWARDSVILLE, KANSAS, FROM THE PROVISIONS OF K.S.A. 12-681 AND 12-682 RELATING TO STREET AND ALLEY IMPROVEMENTS AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECT.

WHEREAS, the City of Edwardsville, Kansas (the "City"), is a city of the second class duly organized and existing under the laws of the State of Kansas;

WHEREAS, pursuant to Article 12, Section 5, of the Constitution of the State of Kansas, cities are empowered to determine their local affairs and government except for legislative enactments applicable uniformly to all cities;

WHEREAS, K.S.A. 12-681 and 12-682 are each enactments which are applicable to the City but which are not uniformly applicable to all cities in that K.S.A. 12-681 and 12-682 apply only to cities of the first class having a population of less than 50,000 inhabitants and cities of the second class; and

WHEREAS, the Governing Body of the City hereby determines that it is in the best interest of the City to exempt the City from K.S.A. 12-681 and 12-682 and to provide substitute and additional provisions on the same subject.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF EDWARDSVILLE, KANSAS, AS FOLLOWS:

Section 1. The City, by the power vested in it by Article 12, Section 5 of the Constitution of the State of Kansas, hereby elects to exempt itself from and make inapplicable to it the provisions of K.S.A. 12-681 and 12682 and to provide substitute and additional provisions as hereinafter set forth in this Charter Ordinance. Such referenced provisions are either enactments or a part thereof which are applicable to the City but are not applicable uniformly to all cities.

Section 2. The substitute and additional provisions for K.S.A. 12-681 shall be as follows:

The City of Edwardsville, Kansas, is empowered to recurb, regutter, resurface or repave, including necessary drainage facilities, any street or alley or any portion thereof when said street or alley has by reason of public travel thereon or by reason of the elements become in need of surface restoration or other construction and improvement, and the governing body shall have the power to determine such need, and when the governing body determines that the making of such improvements is deemed expedient it may by resolution so declare the necessity therefor and cause said improvement to be made. The cost of said recurring, reguttering, resurfacing or repaving, shall be borne by the City at large, and the governing body is hereby empowered to issue general improvement bonds for the purpose of raising funds for making such improvements in an amount not exceeding the total cost of said improvement.

Section 3. This Charter Ordinance shall be published once each week for two consecutive weeks in the official City newspaper.

Section 4. This Charter Ordinance shall take effect 61 days after final publication unless a sufficient peti-

tion for a referendum is filed, requiring a referendum to be held on this Charter Ordinance as provided in Article 12, Section 5 of the Constitution of the State of Kansas, in which case this Charter Ordinance shall become effective upon approval by a majority of the electors voting thereon.

CHARTER ORDINANCE NO. CO-01-25

A charter ordinance exempting the Unified Government of Wyandotte County/Kansas City, Kansas, from the provisions of K.S.A. 12-1697(a) relating to the levy of a transient guest tax, to the minimum rate thereof, and to the purposes for which such transient guest tax monies may be spent; providing substitute and additional provisions on the same subject; and superseding Sections 3 and 4 of Charter Ordinance No. CO-01-18, and amending such sections.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE UNIFIED GOVERNMENT OF WYANDOTTE COUNTY/KANSAS CITY, KANSAS:

Section 1. The Unified Government of Wyandotte County/Kansas City, Kansas, by the power vested in it by article 12, section 5, of the Constitution of the State of Kansas, hereby elects to exempt itself and make inapplicable to it the provisions of paragraph (a) of K.S.A. 12-1697, relating to the levy of a transient guest tax, to the maximum rate thereof, and to the purposes for which such transient guest tax monies may be spent. K.S.A. 12-1697(a) is part of an enactment which is applicable to Kansas City, Kansas, but is not applicable uniformly to all cities. Substitute and additional provisions are enacted in this Charter Ordinance.

Section 2. In order to provide revenues to promote tourism, conventions, economic development related to tourism, and capital improvement of the park system, the governing body of the Unified Government of Wyandotte County/Kansas City, Kansas, is hereby authorized to levy a transient guest tax at a rate not to exceed ten percent, and does hereby levy a transient guest tax at the rate of ten percent from April 1, 2026 through December 31, 2028, upon the gross receipts derived from or paid directly or through an accommodations broker by transient guests for sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel or tourist court within the boundaries of the City of Kansas City, Kansas.

Section 3. No less than three percent (3%) of the total transient guest tax shall be used for capital improvement projects of the parks and recreation department and no less than three percent (3%) of the total transient guest tax shall be transferred to the KCK Convention and Visitors Bureau. The remaining four percent (4%) of the total transient guest tax shall be placed in a Convention and Tourism Fund to be used for the promotion of conventions, the promotion of tourism, and economic development related to tourism within Kansas City, Kansas.

Section 4. The provisions of this ordinance shall supersede Sections 3 and 4 of Charter Ordinance No. CO-01-18 from April 1, 2026, through December 31, 2028, after which the provisions of Sections 2 and 3 of this ordinance shall no longer be in effect. At least 30 days prior to December 31, 2028, the Unified Government shall notify the Kansas Department of Revenue that the rate will revert to eight percent (8%) upon the expiration of Sections 2 and 3 of this ordinance.

Section 5. On and after January 1, 2029, Section 3 of Charter Ordinance No. CO-01-18 shall be amended to read as follows:

Section 3. In order to provide

revenues to promote tourism, conventions, economic development related to tourism, and capital improvement of the park system, the governing body of the Unified Government of Wyandotte County/Kansas City, Kansas, is hereby authorized to levy a transient guest tax at a rate not to exceed eight percent (8%), and does hereby levy a transient guest tax at the rate of eight percent (8%), upon the gross receipts derived from or paid directly or through an accommodations broker by transient guests for sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel or tourist court within the boundaries of the City of Kansas City, Kansas.

Section 6. On and after January 1, 2029, Section 4 of Charter Ordinance No. CO-01-18 shall be amended to read as follows:

Section 4. All such receipts derived from the transient guest tax shall be placed in a Convention and Tourism Fund to be used for the promotion of conventions, the promotion of tourism, capital improvement of the park system, and economic development related to tourism within Kansas City, Kansas. No less than three percent (3%) of the total transient guest tax shall be used for capital improvement projects of the parks and recreation department and no less than three percent (3%) of the total transient guest tax shall be transferred to the KCK Convention and Visitors Bureau. The remaining two percent (2%) of the total transient guest tax shall be placed in a Convention and Tourism Fund to be used for the promotion of conventions, the promotion of tourism, and economic development related to tourism within Kansas City, Kansas.

Section 7. This ordinance shall be published once each week for two consecutive weeks in The Wyandotte Echo.

Section 8. This is a Charter Ordinance and shall take effect 61 days after final publication, unless a petition signed by a number of electors within the City of Kansas City, Kansas, equal to not less than ten percent of the number of electors who voted at the last preceding regular election shall be filed in the office of the Unified Government Clerk demanding that this Charter Ordinance be submitted to a vote of the electors of the City of Kansas City, Kansas, in which event this Charter Ordinance shall take effect when approved by a majority of the electors of the City of Kansas City, Kansas, voting at an election held for such purpose.
